In producing herewith four arrested person namely 1) Akshay Hembram (31 yrs) S/0 Lt Dukhuharan Hembram of Vill- Baramesia, PS Adra, Dist- Purulia, 2) Dilip Hembram (26 Yrs), S/O- Jagan Hembram of Do. 3) Parameswar Hembram (22 Yrs), s/o-Jagan Hembram of Do. 4) Dinabandhu Hembram (26 Yrs), S/O Lt. Dugai Hembram of Do, along with seized One Red colour Mahindra B 275 DI, Tractor bearing Chassis Number-C0650090901A3/DS069, having number plate in partially damaged condition along with sand loaded Red Trolley without number plate seized under proper seizure list and memo of arrest in respect of the supra person before you.

The nub of the fact in a nutshell is that today 24.03.2023 while I along with force namely 1) C/506 Bhutnath Sing Sarder 2) NVF/969 Pralay Mahato left the PS for performing evening Petrol duty vide CC No-876 Dated 24.03.2023 and Adra PS GDE No 958 Dated 24.03.2023 in PS area. During my petrol duty, I received a tip off at 22:15 hrs that a suspicious tractor loaded with sand was coming from Kashipur road side towards Adra Town, Purulia. Subsequently, I along with force proceeded towards engineering ground more to work out the tip off. While I along with force arrived at near Engineering ground More. I asked local people who gathered at that place to become witnesses but none came forwarded and all of them left the place. After that I found that one tractor was coming from Kashipur side under Adra PS. I along with force intercepted the vehicle (Tractor) with a registration number plate in partially damaged condition attached with Red colour Trolley loaded with sand after placing the guardrail on the road at 22:35 hrs at Engineering ground More and found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver and workers of the said vehicle disclosed their name noted in the supra. I asked them to produce the valid documents in respect of the vehicle as well as the loaded sand. But they could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked them to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious one to us. It was ascertained that the driver of the said tractor along with workers loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Darkeswar River at Jamkuri Bali Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. During interrogation the driver and the workers clearly confessed that they habitually deal with the clandestine business and assisting in concealment and disposing voluntarily of stolen sand in a clandestine manner since years, also violating the Govt. notification/order. They also violating the order notification vide DM, Purulia Memo No - VI/430 (Part - VII)/ 1176/M/90/M/17 Dtd.26.06.2020, regarding ban of sand lifting from Riverbed. So I, seized the tractor bearing Chassis Number-C0650090901A3/DS069, having number plate in partially damaged condition along with sand loaded Red Trolley without number plate under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely 1) Akshay hembram (31 yrs) S/0 Lt Dukhuharan Hembram of Vill- Baramesia, PS Adra, Dist-Purulia and the workers namely 2) Dilip Hembram (26 Yrs), S/O- Jagan Hembram of Do. 3) Parameswar Hembram (22 Yrs), s/o-Jagan Hembram of Do. 4) Dinabandhu Hembram (26 Yrs), S/O Lt. dugai Hembram of Do, after informing the ground of arrest and issued Memo of Arrest against them. Thereafter, I brought the said tractor to Adra P.S.

Under the above facts and circumstances kindly take lawful action against the driver namely1) Akshay hembram (31 yrs) S/0 Lt Dukhuharan Hembram of Vill- Baramesia, PS Adra, Dist- Purulia and the workers namely 2) Dilip Hembram (26 Yrs), S/O- Jagan Hembram of Do. 3) Parameswar Hembram (22 Yrs), s/o-Jagan Hembram of Do. 4) Dinabandhu Hembram (26 Yrs), S/O Lt. dugai Hembram of Do, and the owner of the vehicle as they committed offence U/S
