Sub: To lodge FIR against owner and driver of tractor namely Bablu Rajwar (32 yrs) S/O Shibaram Rajwar of vill- Hensla, PS- Arsha, Dist- Purulia of one Blue colour New Holland-3037 tractor having Reg. No. WB55B/4665 along with trolley loaded with sand (approx 60 CFT).

Sir,

In producing herewith, 01(one) Blue colour New Holland-3037 tractor having Reg. No. WB55B/4665 along with trolley loaded with sand (approx 60 CFT). Today on 05.03.23 at about 17.35 hrs. acting on source information, I SI Uttam Kr. Mandal of Arsha PS along with (i) C/-1516 Arnab Sinha and (ii) C/222 Pravash Ch. Mandal both of Arsha PS, Dist-Purulia, left for PS area vide C.C No. 606 Dtd. 05.03.2023. After we reached at Hensla Ghat, under Arsha PS at 18.45 hrs, we conducted raid on the Bank of Bandu River under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Hensla Ghat on the Bank of Bandu River. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party the driver namely Bablu Rajwar (32 yrs) S/O Shibaram Rajwar of vill- Hensla, PS- Arsha, Dist- Purulia of said tractor tried to flee away, but we apprehended him. I asked him to produce valid documents in support of carrying sand, but he could not produce as such documents. Hence I seized the above noted tractor along with trolley loaded with sand (approx 60 cft) and arrested the driver Bablu Rajwar (32 yrs) S/O Shibaram Rajwar of vill- Hensla, PS- Arsha, Dist- Purulia after issuing memo of arrest and brought the said tractor and the driver to Arsha P.S. As there is every reason to believe that the driver and owner of the said tractor with ill motive were lifting and transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order as they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the 1. owner and driver namely Bablu Rajwar (32 yrs) S/O Shibaram Rajwar of vill- Hensla, PS- Arsha, Dist- Purulia of above noted tractor along with the trolley for investigation.
