In producing here with one arrested accused Ajit Bauri (57 yrs) S/O Lt. Nilkamal Bauri of vill- Uparjambad, P.S.-Arsha Dist-Purulia, A/P Vill- Kanchanpur, PS- Arsha, Dist- Purulia along with following seized articles.

1) One white colour plastic container with approx 19 ltrs. of ID liquor. (Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, ASI Rajib Chakraborty of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 06.03.2023 at about 20.15 hrs. during my anti crime night ,mobile duty at PS area, receive source information over telephone that the above noted accused has been selling ID liquor in his house at Kanchanpur Village. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with i) C/-15 Sushanta Kr. Dev of Arsha PS ii) C/- 300 Binoy Mahato of SAP 7th BN camp at Arsha PS, rushed in the house of Ajit Bauri (57 yrs) S/O Lt. Nilkamal Bauri of Vill- Kanchanpur, PS- Arsha, Dist- Purulia to work out the information vide Arsha PS Spl. C.C. No. 615/23 dtd. 06.03.23 and GDE No. 295 Dtd. 06.03.23. Reaching at his house at about 20.55 hrs we fixed-up in the house of above noted accd. person and found that selling of Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person. On demand of showing papers he failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused Ajit Bauri (57 yrs) S/O Lt. Nilkamal Bauri of vill Uparjambad, P.S.-Arsha Dist-Purulia, A/P Vill-Kanchanpur, PS- Arsha, Dist-Purulia under proper section of law.
