Sir,
I, SI Nikhil Pratap Singh of Arsha PS do here by lodge a complaint as suo-moto against Santosh Kumar @ Bocha S/O Mutru Kumar of Vill- Baghadih, PS- Balarampur, Dist- Purulia & 05-06 unknown persons to the effect that on 28.03.23 during my mobile duty at Kantadih side area at about 19.35 hrs received an credible information that a gang of dacoits with deadly weapons and vehicle assembled at Kantadih Basti near new construction of over bridge under P.S-Arsha, Dist.-Purulia and they were preparing themselves for committing dacoity. This matter was informed to my O/C, Arsha PS and as per his direction myself accompanied with C/960 Satyajit Mondal and C/930 Sanjit Gorai both of Kantadih Police camp immediately proceeded to the anticipated place of assembly to work out the information vide Kantadih Police Camp GDE No. 524 & C.C No. 59/23 Dtd. 28.03.2023. We reached at Kantadih Basti near new construction over bridge at about 20.25 hrs, we noticed that 06-07 some unknown persons assembled at the back side of the Kantadih new construction over-bridge near Kantadih Basti and those persons were whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously, I commanded them to surrender but they did not pay any heed and tried to flee away. After a hot chase, I identified one of them as Santosh Kumar @ Bocha S/O Mutru Kumar of Vill- Baghadih, PS- Balarampur, Dist- Purulia but did not catch him. We searched the area and seized 1. One vehicle (Tata AC Gold) having Reg. No. WB55B/6603, 2. 02 (two) nos of iron rod length approx 05 feet & 4 feet, 3. 02 (two) Pcs of Lathi, 4. 01 (one) nylon rope approx length 15 ft, from the P.O under proper seizure list duly sign by the Police witnesses as because it was dead hour of night, a lonely place and also as per the information they assembled and making preparation for committing dacoity with deadly weapons which might endanger of life of Public witnesses, so I restrained from collecting public witnesses. Under such circumstances it is reasonably believed that the above noted persons were assembled there for committing house dacoity.

Therefore, I pray that a specific case may kindly be registered against Santosh Kumar @ Bocha S/O Mutru Kumar of Vill- Baghadih, PS- Balarampur, Dist- Purulia & 05-06 unknown persons under proper section of law.
