Sir,

In producing herewith the one accused person namely Amar Sing Babu (28), S/O-Lt-Nunu Sing Babu of Vill-Dugdha, PS- Baghmundi, Dist- Purulia along with seized articles (1) One white plastic jeri can containing approx 07 (Seven) liter of ID Liquor, (2) 04 (Four) pieces small steel glasses, (3) 500 ml I.D liquor from Sl No. 1 as sample which were seized under proper seizure list duly signed by the witnesses.

I beg to submit that today on 04.03.2023 during my mobile duty as per Suisa OP C.C No-337/2023 & Suisa OP GDE No-121, Dtd: 04.03.2023 received source information. Accordingly, I SI Saurav Kanti Das along with force 1. C/2010 Rintu Gorai, 2. C/2669 Prabir Singh Mahapatra both Suisa OP under Baghmundi PS, Dist-Purulia reached at Dugdha village at about 18:05 hrs and found that the above noted person is selling I.D liquor in his tea stall near Dugdha Durga Mandir. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. In between 18:15 hrs to 18:25 hrs I seized (1) One white plastic jeri can containing approx 07 (Seven) liter of ID Liquor, (2) 04 (Four) pieces small steel glasses, (3) 500 ml I.D liquor from Sl No. 1 as sample from his possession U/S- 67 B.E Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witnesses and accused person. Hence I arrested the above noted person at 18:35 hrs after maintaining all formalities and guidelines regarding arrest. I offered him for medical treatment but he refused.

The above noted arrested accused person namely Amar Sing Babu (28), S/O-Lt-Nunu Sing Babu of Vill-Dugdha, PS- Baghmundi, Dist- Purulia committed an offence U/S- 46 (A)(c) B.E Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific case may kindly be started against the said accused person under proper section of law and arrange its investigation.
