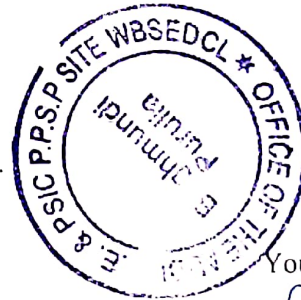
Sir,

As intimated in writing to Bagmundi PS by Sri Debasish Chaudhury, DE(E) -Store, PPSP Site on 17.03.2023 and as per his Statement of Facts dtd. 18.03.2023 (enclosed), the undersigned is to inform you that ten nos. copper windings of Synchronous Generator amounting Rs. 85 Lac (Rs. Eighty Five Lac) approx, as per counting till now, had been stolen by some miscreants from Purulia Pumped Storage Project (PPSP) Site Store beside PPSP canteen on 17.03.2023 at around 1.30 hours. Counting is still on process. Weight of each copper winding will be around fifty Kg.


On completion of total counting, the undersigned will intimate you the exact figure (No. of copper windings along with total amount of theft) in this regard.

Kindly treat this as FIR and take appropriate immediate action to recover the stolen materials and book the miscreants under your custody .
