Respected Sir,

In producing herewith the driver namely Susanta Kumar (36 yrs) S/O- Lt. Nimai Kumar of Vill- Muradih, P.O- Bhabanipur, P.S- Barabazar, Dist- Purulia along with seized Tractor (Blue & White colour), Model- Swaraj-744FE, Mahindra & Mahindra Ltd Company, vide its Chassis No- MBNAU52AHJCN15942 and Engine No- 43.1024/SZN39708 attached with loaded Sand Trolley (approx 100 cft) and with Seizure list, Memo of Arrest and Inspection Memo in respect of the supra persons before you.

The nub of the fact in a nutshell is that on 17.03.2023 at 22:45 hrs while I along with force 1) C/1304 Dhananjay Mondal and 2) C/246 Chanchal Chakraborty all of Balarampur PS left the PS for performing Evening mobile duty vide Balarampur PS CC No 1239 date- 17.03.2023 and GDE No 783 Dt. 17.03.2023 in PS area. During my evening mobile duty, I received a tip off at 22:15 hrs that a suspicious tractor loaded with sand was loading sand at Hanumata River Ghat and will be proceeding towards Supurdih and Tuima village. I inform the matter to O/C Balarampur P.S and as per his kind direction, I along with force proceeded towards Hanumata River Ghat as well as Supurdih village for work out the tip off. While I along with force arrived at Supurdih at about 23:45 hrs and found 01 (one) sand loaded tractor was proceeding towards Supurdih village. I along with force intercepted the vehicle (Tractor) without its number plate, vide Tractor (Blue & White colour), Model- Swaraj-744FE, Mahindra & Mahindra Ltd Company, vide its Chassis No- MBNAU52AHJCN15942, Engine No- 43.1024/SZN39708 attached with loaded Sand Trolley attached with Trolley loaded with Sand at 23:45 hrs and I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the said vehicle disclosed his name as noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and he have been running a clandestine business. So it is reasoned to belief that he in cahoots with the others of the vehicle procured the said sand form Hanumata river side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the Tractor (Blue & White colour), Model- Swaraj-744FE, Mahindra & Mahindra Ltd Company, vide its Chassis No- MBNAU52AHJCN15942, Engine No- 43.1024/SZN39708 attached with loaded Sand Trolley under proper seizure list in presence of available witnesses duly signed by him and also arrested the driver namely Susanta Kumar (36 yrs) S/O- Lt. Nimai Kumar of Vill- Muradih, P.O- Bhabanipur, P.S- Barabazar, Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest and Inspection Memo against him. Thereafter, I brought the seized tractor to Balarampur PS compound.

Under the above facts and circumstances kindly take lawful action against the driver namely Susanta Kumar (36 yrs) S/O- Lt. Nimai Kumar of Vill- Muradih, P.O- Bhabanipur, P.S- Barabazar, Dist- Purulia of the vehicle as he committed offence U/S 379/411/414 of the IPC & 21(1) (4) of Mines and Minerals (R&D) Act-1957.
