Respected Sir,

In producing here with one arrested accused person namely Nitai Gope (60 yrs) S/O-Lt. Purna Gope of Vill- Diputarh, P.S-Balarampur, Dist. Purulia along with seized 11 (eleven) bottles Country sprit style as "Dil Se" each bottle containing 600 ML (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 20:05 hrs. during my evening mobile duty with C/1304 Dhananjay Mondal & C/468 Raju Roy, vide Balarampur P.S C.C No-1322/23 and GDE No- 978 dated- 21.03.2023, I received a credible source information that one Nitai Gope (60 yrs) S/O-Lt. Purna Gope of Vill- Diputarh, P.S-Balarampur, Dist. Purulia is selling Country sprit "Dil Se" without any valid license from his Tea Pakora shop at Diputar village, P.S-Balarampur, Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for at Diputar village to work out the source information. Thereafter we reached at Diputar village at about 20:35 hrs as per source information, I along with force held raid in the Tea Pakora shop of Nitai Gope.

During search with the help of accompany with force, we found that the said person is selling Country sprit at Diputarh village. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit. Accordingly, I seized the said 11 (eleven) bottles Country sprit style as "Dil Se" each 600 ML (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle (600 ML) as a sample. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(c) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(c) B.E. Act against the arrested accused person namely Nitai Gope (60 yrs) S/O-Lt. Purna Gope of Vill- Diputarh, P.S-Balarampur, Dist. Purulia to start a cog case U/S 46A(c)B.E. Act and arrange for its investigation.
