Respected Sir,

In producing here with arrested accused person Shankar Gorai @ Mithun (51 yrs) S/O- Lt. Ratan Gorai of Vill- Bela, P.O- Rangadih, P.S-Balarampur, Dist.-Purulia along with seized articles 1) One sponge iron loaded Trailer Truck (18 wheelers) vide its Reg. No- JH05DH/4084, Approx loaded with 30 - 35 Mt. sponge iron, 2) Approx 700 Kg sponge iron, 3) 35 (thirty five) pieces iron rod (10 mm) each length approx 40 feet, 4) One "AXIS" Company's electronic weight machine, 5) 04 (four) pieces Shovels, 6) 05 (five) pieces of iron baskets (details of seized articles are mentioned in attached seizure list), I beg to report that today (27.03.2023) while myself along with force were performing mobile duty vide Balarampur P.S C.C No- 1643/2023 and GDE No- 1274 date- 27.03.2023, received a secret information from credible source at about 18:05 hrs. that some illegal business regarding iron cutting/ sponge iron cutting and other articles cutting from the loaded vehicles is going on at Malti near "MAA Hotel" by the side of NH-32 road towards Balarampur – Tata main road where Shankar Gorai and others are running the business. Then I inform and brought to notice the matter to duty officer at P.S at 18:25 hrs. and proceeded towards to work out the source information as per kind order of superior. I along with force reached to the spot at about 18:45 hrs. and surrounded the area by the force. On seeing the Police party some persons fled away, after hot chase one person can be apprehended and on being asked him to disclosed his identity as Shankar Gorai (51 yrs) S/O- Lt. Ratan Gorai of Vill- Bela, P.S-Balarampur, Dist.-Purulia and he stated that he is running the illegal cutting business with the help of others by dishonestly and running a clandestine business in habitually.

Then we proceeded to the back side of the shop of Shankar Gorai and found that the back side is a big open land having a big iron gate. We found in the east side one Truck having Regd. No- JH05DH/4084 loaded with sponge iron standing there and some portion are loaded sponge iron removed from the said loaded Truck and the removed portion of the sponge iron are heaped which lying back side of the said Truck (which sponge iron were descended down from the said truck) one weighing machine, some iron buckets / dhama, some shoves are found there. I also found a huge quantity of sponge iron (approx 700 Kg) and some iron rod 35 pieces in the another room. Hence I seized 1) One sponge iron loaded Trailer Truck (18 wheelers) vide its Reg. No- JH05DH/4084, Approx loaded with 30 - 35 Mt. sponge iron, 2) Approx 700 Kg sponge iron, 3) 35 (thirty five) pieces iron rod (10 mm) each length approx 40 feet, 4) One "AXIS" Company's electronic weight machine, 5) 04 (four) pieces Shovels, 6) 05 (five) pieces of iron baskets under proper seizure list which duly signed by the witnesses. So I arrested the accused person namely Shankar Gorai @ Mithun (51 yrs) S/O- Lt. Ratan Gorai of Vill- Bela, P.S-Balarampur, Dist.-Purulia after maintaining proper formalities who confessed his guilty. It is reasonably belief that arrested Shankar Gorai the driver and helper and others made a criminal conspiracy to remove or transfer the sponge iron, iron rod from the Truck illegally and to sale same this property to others with a view to wrongful gain and also to cheated his owner of the actual property.

So, I pray a case U/S- 379/406/411/413/414/420/120B IPC may kindly be started against accused Shankar Gorai @ Mithun (51 yrs) S/O- Lt. Ratan Gorai of Vill- Bela, P.O- Rangadih, P.S-Balarampur, Dist.-Purulia, driver and owner of the said vehicle (JH05DH/4084), land owner/ Tal owner and others and arrange for its investigation.
