
Most respectfully begs to state as follows: -

- 1. That complainant/petitioner is the socially married wife of accused no.1 namely Ashis Marddanya of Gosala Road, Balarampur, P.O.Rangadih, P.S.Balarampur, Dist.Purulia and marriage in between the petitioner and accused no.1 has been solemnised on 19.4.2016 as per Social customs prevail in their community by performing all the Example formalities of the society.
- 2. That the time of marriage father of the petitioner completed to pay Rs.5,00,000/-(five lakhs) to the accused no.1 and his family members alongwith other ornaments and articles as per their demand.
- 3. That after few days from the date of marriage started to physical and mental torture due to insufficient of dowry given by the father of your petitioner and all the family



(father-in-law), Debasis Marddanya (elder brother-in-law),
Rani Marddanya (mother-in-law) and Sarita Marddanya (w/o lashis
Marddanya) i.e. Bara jaa, all are residing in same mess and
family started to put pressure to bring Additional further
dowry money from the father's house of your petitioner and
as and when petitioner refused, then all type of brutal work
started upon the petitioner by aforesaid accused persons
eveny they assault her off and and frequently.

- best to adjust with the accused and in the mean time one daughter namely Sreya Marddanya has been born, now aged about 5 years residing with the mother and after birth of aforesaid daughter the physical and mental torture increased day to day and finally it was unable and then petitioner informed the matter to her father and other villagers of village penchara and the accused persons snached all the documents of the petitioner and her daughter and drove her out from the house.
- 5. That on several time accused also take attempt to killed her but petitioner did not take any legal steps for future adjustment.
- 6. That heaving such type of inhuman behavior of the



accused persons, the father of the complainant started to settled the matter and on several occasion father of the petitioner alongwith other village people come at the house of the accused and tried their best for solve the situation but the accused persons being well educated man constructly demanding more and more money then at the time of COVID situation father of the petitioner took the petitioner and her daughter to his own house on the hope that matter will be solve on future.

- father of the petitioner alongwith some village head mensor of vill. Penchara went to the matrimonial house of the petitioner to keep them at their laws house but of no good and having been seen they closed the door by saying that without future additional dowry manupoetitioner alongwith her will 2 be not allowed.
- 8. That the accused also threatened to your petitioner by saying that they all ready filed a divorce case before the court.

 and informed the matter but as the accused persons are very
 influencial persons as such the mothem of law was not star-

not started against the accused.

- asking about the possition of the complaint the P.S. search stated already action was started but after such petitioner came to know P.S.did nothing as such the petitioner informed the matter to S.P.Purulia but all in vain.
- 11. That being deserted lady petitioner have no other alternative but to take the shelter of sec.156(3)Cr.P.C. to punished the criminal as per provision of law.

The ist herefore prayed that your Honour may graciously be pleased to pass necessary order to investigate the matter to O.C. Balarampur P.S. after treating it as F.I.R. and the accused be punished as per provision of law.
