Respected Sir,

In producing here with arrested accused person namely Durgacharan Singh (53 yrs), S/O- Lt. Lusu Singh of Vill- Chirudih, PO- Chirudih Radhanagar, PS-Bandwan, Dist-Purulia along with seized Illicit Distill figuor & other seized articles I beg to submit that today i.e. on 06.03.23 at about 12:15 hrs I received a credible source information while I was engaged in day Mobile duty that one person as mentioned above is selling Illicit Distilled liquor without any valid license at the house where he resides at Vill- Chirudih, PO- Chirudih Radhanagar, PS-Bandwan, Dist-Purulia . Accordingly, I along with force (C/1463 Santimoy Ghosh & C/788 Rabindra Nath Baidya both are of Bandwan P.S.) vide Bandwan P.S. C.C. No. 808/23 Dtd: 06/03/23 left for Vill- Chirudih, PO- Chirudih Radhanagar, PS-Bandwan, Dist-Purulia to work out the said source information and held raid at that particular place as identified by the source and found that the said person has stocked Illicit Distilled liquor in a Jaricane and 10 (ten) sealed bottles of Officer's Choice Grand Whisky containing 180 ml in each bottle with pricing 150 RS/- in each bottle. On asking he disclosed his identity as noted above and stated that he usually stocks illicit distilled liquor and bottles of foreign liquors for the purpose of sell. On demand, he failed to produce any valid documents/ License in respect of preparing, stocking and selling of Illicit Distilled liquor and foreign liquors. Accordingly, I seized 10 litre Illicit distilled liquor carried in a jarricane and ten sealed bottles of Officer's Choice Grand Whisky containing 180 ml in each bottle after preparing proper seizure list duly signed by the witnesses and the seizure was done in between 12:55 hrs to 13:30 hrs. One litre Illicit Distilled liquor has been kept & labeled as sample bottle and one sealed bottle of Officer's Choice Grand Whisky containing 180 ml with pricing 150 RS/- has been kept & labeled as sample bottle. Then, I arrested him after preparing proper arrest memo and maintaining all other legal formalities as laid down by Hon'ble Supreme Court at 13:45 hrs as he committed offence U/S-46A(C) B.E. Act 1909 and took him to PS and put in lock up maintain all Hazat rules. .

Under the above circumstances and fact, I therefore pray that a Cog. case may kindly be started U/S-46A(C) B.E. Act 1909 against the arrested accused person namely Durgacharan Singh (\$2 yrs), S/O- Lt. Lusu Singh of Vill- Chirudih, PO- Chirudih Radhanagar, PS-Bandwan, Dist-Purulia and arrange for its investigation.
