Sub: Complaint against (i) Nilkantha Mahato (64 Yrs) S/o- Lt. Bihari Mahato & (ii) Dinesh Mahato (34 Yrs) S/o- Lt. Jahar Mahato both of Vill- Tokoria, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing herewith the arrested accused persons namely (i) Nilkantha Mahato (64 Yrs) S/o- Lt. Bihari Mahato & (ii) Dinesh Mahato (34 Yrs) S/o- Lt. Jahar Mahato both of Vill- Tokoria, PS- Barabazar, Dist- Purulia and seized one white colour plastic Jerakin containing approx 09 (Nine) Litters I.D liquor (Cholai) on which ½ Ltr. seized as sample from the mother contraband as sample as per enclosed seizure list.

I, PSI Alope Rana of Barabazar PS do here by lodge this complaint against (i) Nilkantha Mahato (64 Yrs) S/o- Lt. Bihari Mahato & (ii) Dinesh Mahato (34 Yrs) S/o- Lt. Jahar Mahato both of Vill- Tokoria, PS- Barabazar, Dist- Purulia. I beg to state that today i.e. on 05.03.2023 myself along with C/- 111 Samulal Tudu & C/-1187 Samar Kanta Maity were left for day mobile duty vide Barabazar PS GDE No- 286 Dtd. 05.03.2023. During mobile duty at about 13.05 hrs I received information that some persons was selling I.D liquor (Cholai) near Tokoria Village under Barabazar PS. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said area to work out the information. At about 13.55 hrs as per source information myself along with force held a raid in front the house of Sarathi Singh Sardar W/o- Lt. Lodha Singh Sardar of Vill-Tokoria under Barabazar PS and found that the above noted persons were keeping & selling I.D Liquor (Cholai) from there. Seeing the Police party buyers fled away, but we apprehended the sellers who were kept & selling I.D Liquor (Cholai). On search I found one white colour plastic Jerakin containing approx 09 (Nine) Litters I.D liquor (Cholai). On demand, they failed to produce any valid documents / License in respect of keeping & selling I.D liquors (Cholai). On being asked they confessed their guilt and stated that they were selling the I.D liquors (Cholai) to the local peoples with intent to make their own profit. They disclosed their identity as above noted. They also admitted that they have no license or any authorization for keeping or selling of I.D liquors (Cholai). Accordingly, I seized above noted I.D Liquor (Cholai) after preparing proper seizure list and put label on the seized articles in presence of the witnesses and on which ½ Ltr. of I.D liquor taken as sample from the mother contraband which were also duly labeled by me and also took signature of the accompanying forces as witness on seizure list and label as well as accused persons also. I try to find local witnesses but no one turns up before me. The seizure and label was done in between 14.05 hrs and 14.15 hrs.

Thereafter, I arrested the accused persons namely (i) Nilkantha Mahato (64 Yrs) S/o- Lt. Bihari Mahato & (ii) Dinesh Mahato (34 Yrs) S/o- Lt. Jahar Mahato both of Vill- Tokoria, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed them and their relatives regarding the grounds of arrest. The arrest was made on 05.03.2023 at 14.15 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused persons namely (i) Nilkantha Mahato (64 Yrs) S/o- Lt. Bihari Mahato & (ii) Dinesh Mahato (34 Yrs) S/o- Lt. Jahar Mahato both of Vill- Tokoria, PS- Barabazar, Dist- Purulia under proper section of Law.
