Sir,

In producing herewith the arrested accused person namely Sunil Chandra Hembram (59 Yrs) S/o-Lt. Shaban Hembram of Vill- Puijanga, P.O-Herbona, PS- Barabazar, Dist- Purulia and seized one plastic Jerakin containing approx 09 (Nine) Litters I.D liquor (Cholai) on which 500 ml seized as sample from the mother contraband as sample as per enclosed seizure list.

I, ASI Manas Kr. Pan of Barabazar PS do here by lodge this complaint against Sunil Chandra Hembram (59 Yrs) S/o-Lt. Shaban Hembram of Vill- Puijanga, P.O-Herbona, PS-Barabazar, Dist-Purulia. I beg to state that today i.e. on 05.03.2023 myself along with C/-677 Syed Julhar Ali & C/-897 Umapada Dhalla were left for evening mobile duty vide Barabazar PS GDE No- 306 Dtd. 05.03.2023. During mobile duty at about 17.25 hrs I received information that one person was selling I.D liquor (Cholai) at Puijanga Village under Barabazar PS. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said area to work out the information. At about 17.55 hrs as per source information myself along with force held a raid beside the house of above noted person and found that the above noted person was keeping & selling I.D Liquor (Cholai) from there. Seeing the Police party buyers fled away, but we apprehended the seller who was kept & selling I.D Liquor (Cholai). On search I found one plastic Jerakin containing approx 09 (Nine) Litters I.D liquor (Cholai). On demand, he failed to produce any valid documents / License in respect of keeping & selling I.D liquors (Cholai). On being asked he confessed his guilt and stated that he was selling the I.D liquors (Cholai) to the local peoples with intent to make his own profit. He disclosed his identity as noted above. He also admitted that he has no license or any authorization for keeping or selling of I.D liquors (Cholai). Accordingly, I seized the above noted I.D Liquor (Cholai) under proper seizure list duly signed by witnesses. I also took 500 ml of ID Liquor (Cholai) from mother contraband. I put label on the seized articles & sample also duly singed by witnesses as well as accused person also. The seizure and label was done in between 18.05 hrs and 18.35 hrs.

Thereafter, I arrested the accused person namely Sunil Chandra Hembram (59 Yrs) S/o-Lt. Shaban Hembram of Vill- Puijanga, P.O-Herbona, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his relatives regarding the grounds of arrest. The arrest was made on 05.03.2023 at 18.35 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be register against the arrested accused person namely Sunil Chandra Hembram (59 Yrs) S/o-Lt. Shaban Hembram of Vill- Puijanga, P.O-Herbona, PS- Barabazar, Dist- Purulia under proper section of Law.
