I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007 to the effect that BIRBAL GORAIN S/O LATE TANU GORAIN of Vill- DHADANGA,NISCHINTAPUR, P.S- Barabazar , Dist- Purulia,has committed theft of electricity U/S 135(1)/e of electricity act 2003 subsequently amendment act 2007.

On 21.03.2023 at about 13.30 ^{hrs} P.M. I Sri Banti Karmakar, AE & Station Manager, Barabazar CCC along with 01. Shibaji Chakraborty,JE(E) GR-II, Barabazar CCC, 02. Mandeep Chakladar,OE, Barabazar CCC entered at domestic building site of BIRBAL GORAIN S/O LATE TANU GORAIN of Vill- DHADANGA,NISCHINTAPUR, P.S- Barabazar , Dist- Purulia and found Birbal Gorain, was supply the electricity from her existing meter (BB1123175) unauthorisely to nearby another premises for construction of big building with the help of 6 Sq. mm two core PVC Cable of 110 mtr approx by unauthorized supply of electricity from her domestic premise and connected load found 1.5 H.P. As that of Birbal Gorain S/O Late Tanu Gorain committed theft of electric power. So, I Seized the following articles after preparing the seizer list in presence of 01. Shibaji Chakraborty, J.E GR II. 
