I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003 "subsequently electricity act-2007 to the effect that SUNIL CH MAHATA S/O LATE CHEPULAL MAHATO of Vill- PURIHANSA, P.S- Barabazar, Dist- Purulia, has committed theft of electricity U/S 135(1)/e of electricity act 2003 subsequently amendment act 2007.

On 22.03.2023 at about 12.05 P.M. I Sri Banti Karmakar, AE & Station Manager, Barabazar CCC along with 01. Shibaji Chakraborty, JE(E) GR-II, Barabazar CCC, 02. Suresh Sao, OE, Barabazar CCC entered at domestic building site of SUNIL CH MAHATA S/O LATE CHEPULAL MAHATO of Vill- PURIHANSA, P.S- Barabazar, Dist- Purulia and found Sunil Chandra Mahato, was supplying the electricity from his existing meter (L1674893)(Which is Defective) unauthorisely to nearby another premises for construction of big building with the help of 6 Sq. mm two core PVC Cable of 80 mtr approx by unauthorized supply of electricity from her domestic premise and connected load found 0.5 KVA. As that of SUNIL CH MAHATA S/O LATE CHEPULAL MAHATO of Vill- PURIHANSA committed theft of electric power. So, I Seized the following articles after preparing the seizer list in presence of 01.
