I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Asit Baran Mahato S/O- Joy Krishna Mahato of Village- Bari, P.O- Bari, P.S.- Boro, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 23.03.23 at about 4.50 PM, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Asit Baran Mahato, S/O- Joy Krishna Mahato of Village- Bari, P.O- Bari, P.S.- Boro, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from nearest transformer LT fuse unit.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) 2 HP submersible pump.

out of which we seized the following -

- 1) 6 sq mm PVC cable 80 mtr approx.
- 2) 2.5 sq mm PVC cable 50 mtr approx.
- 3) 1 no 1ph submersible pump Controller.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 5.25 PM on dated 23.03.23. The accused person has committed an offence U/S 135(1)(a) of the Electricity ACT 2003 (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
