I Jiten Kumar Nandi (Age- 70 Yrs), S/O- Lt. Ganesh Chandra Nandi of Arabinda Sarani, Indraprastha Colony, Deshbandhu Road, Purulia Municipality Ward No- 21, PS- Purulia Town, Dist- Purulia would like to inform you that on 17/02/2023 at about 1.30 PM I received a phone call from an unknown person Vide Mobile No- 06289074236 who disclosed himself as a representative of Electricity Consumer Care and told me that my electricity bill was due and if I did not pay the due amount my electricity connection would be disconnected. Then being afraid of this information, to pay the due amount I followed his instruction and installed an app namely "QuickSupport" and made a recharge of Rs.21/-. A few minutes later, I found that a total amount of Rs.199,000/- was debited from my SBI bank Account No-32427247776, IFSC- SBIN0010227. Then I realized that I have been cheated by some unknown miscreants.

So, I request you to kindly take further step as soon as possible and refund the unauthorized transaction amount. I could not lodge FIR at the time of starting the incident as because I could not collect the sufficient relied documents in support of the incident.
