Sir,

In producing here with one (01) accd namely Mukul Kumar (45 yrs.) S/O- Lt. Ramashray Sing of Vill+PO- Swang, PS- Birsa, Dist- Bokaro, Jharkhand Driver of vehicle (Truck) having registration No- JH10BJ/3443 along with seized vehicle having registration No- JH10BJ/3443 loaded with approx 25 MTs coal, seems to be steam coal to the effect that today on 03.03.2023 I ASI Chiranjit Pal along with C/1429 Jagadish Ch. Mahato, NVF/68 Mahanta Mahato and others all are of Hura P.S were engaged in Naka checking duty on NH60A (Purulia-Bankura road) at Shyamukgoria near Pather Sathi Motel vide Hura P.S CC No 579/23 Dtd 03.03.2023 and GDE No- 108 Dtd- 03.03.2023 and at about 18.05 hrs we found that one vehicle registration No- JH10BJ/3443 loaded with coal was coming from Purulia side . We managed to stop the said vehicle and asked the driver to produce valid document in respect of loaded coal but he failed to supply any valid/legal documents in respect of loaded coal and failed to give any satisfactory reason. The matter intimated to O/C Hura. As such there is every reason to believe that the driver and owner of the said truck with ill motive was transporting the coal illegally without any valid document in support of carrying coal. So, they committed offence punishable U/S- 379/411/414/120B IPC & 30(2) CMN Act.. Hence I seized the said Truck bearing No- JH10BJ/3443 loaded with coal approx 25 MTs under proper seizure list in presence of police witnesses duly signed by them and also taken sample of 05 kg from the truck and arrested the driver namely Mukul Kumar (45 yrs.) S/O- Lt. Ramashray Sing of Vill+PO- Swang, PS- Birsa, Dist- Bokaro, Jharkhand after observing all formalities regarding arrest and brought the said Truck loaded with coal and driver to Hura P.S and kept at PS compound.

Therefore, I pray that a specific case may kindly be registered against above noted arrested driver and owner of the seized vehicle U/S- 379/411/414/120B IPC & 30(2) CMN Act. and arrange it investigation.
