In producing here with 04 accused persons namely (1) Sandeep Yadav (28) S/O-Jafri Yadav of Vill-Rampur, PS-Laxmipur, Dist-Jamui (Bihar), Driver of vehicle No- WB 39B/2428 (2) Jitendra Tanti (32) S/O-Bashudev Tanti of Vill-Jharudih, PS-Belhar, Dist-Banka (Bihar) Driver of vehicle No- WB39B/3470 (3) Mithun Yadav (35) S/O-Chamaklal Yadav of Vill-Bari Manjhgain, PS-Haweli Kharagpur, Dist-Munger (Bihar) Driver of vehicle No- WB39C/0948 (4) Monoj Yadav (28) S/O-Rameswar Yadav of Vill-Harlawar, PS-Laxmipur, Dist-Jamui (Bihar) along with seized articles i.e. 04 (four) vehicles having registration Nos (1)WB 39B/2428 loaded with approx 24 MTs Coal (2) WB39B/3470 loaded with approx 24 MTs Coal (3)WB39C/1810 loaded with approx 29 MTs Coal (4)WB39C/0948 loaded with approx 33 MTs Coal, seems to be steam Coal to the effect that today on 07.03.2023 I ASI Bipin Ch Mahato along with C/2654 Nitai Mandal , NVF/680 Bivas Mandi and others all are of Hura P.S were engaged in Naka checking duty on NH60A (Purulia-Bankura road) at Shyamukgoria near Pather Sathi Motel vide Hura P.S CC No 624/23 Dtd 07.03.2023 and GDE No- 323 Dtd- 07.03.2023 and at about 16.15 hrs we found that Four(04)vehicles registration No- WB 39B/2428, WB39B/3470, WB39C/1810 and WB39C/0948 all loaded with coal were coming from Purulia side towards Bankura. We managed to stop the said vehicles and asked the driver of the all vehicles to produce valid document in respect of loaded coal but they failed to supply any valid/legal documents in respect of loaded coal and failed to give any satisfactory reason. The matter intimated to O/C Hura. As such there is every reason to believe that the drivers, owners and others of the said trucks with ill motive was transporting the coal illegally without any valid document in support of carrying coal. So, they committed offence punishable U/S- 379/411/414/120B IPC & 30(2) CMN Act. Hence I seized the all Four(04) Trucks loaded with coal (Details are mentioned in the attached seizure list) under proper seizure list in presence of police witnesses duly signed by them and also taken sample of 05 kg from the each truck and arrested the above noted Four(04) drivers after observing all formalities regarding arrest and brought the said Trucks loaded with coal and arrested drivers to Hura P.S and the vehicles kept at PS compound.

Therefore, I pray that a specific case may kindly be registered against above noted arrested drivers namely (1) Sandeep Yadav (28) S/O-Jafri Yadav of Vill-Rampur, PS-Laxmipur, Dist-Jamui (Bihar), Driver of vehicle No- WB 39B/2428 (2) Jitendra Tanti (32) S/O-Bashudev Tanti of Vill-Jharudih, PS-Belhar, Dist-Banka (Bihar) Driver of vehicle No- WB39B/3470 (3) Mithun Yadav (35) S/O-Chamaklal Yadav of Vill-Bari manjhgaon, PS-Haweli Kharagpur, Dist-Munger (Bihar) Driver of vehicle No- WB39C/0948 (4) Monoj Yadav (28) S/O-Rameswar Yadav of Vill-Harlawar, Ps-Laxmipur, Dist-Jamui (Bihar),owner of the seized vehicles and others U/S-379/411/414/120B IPC & 30(2) CMN Act. and arrange its investigation.
