In producing herewith one arrested accused namely Anup Kr. Gope (38 yrs.) S/O- Lt. Anil Ch. Gope of Vill- Ladhurka, PS- Hura, Dist- Purulia with Arrest Memo, seizure list, other related papers and seized articles such as one iron made improvised country made firearms(Revolver) having length of 19 cm (approx) with butt, barrel, firing pin, trigger etc. The length of the barrel is 07 cm (approx) and two live ammunition under proper seizure list and being labeled properly, I beg to inform you that today on 02.03.2023 during my Evening/night mobile duty at Ladhurka side under Hura PS area vide Hura PS CC No-574/23 Dtd-02.03.2023 & GDE No-88 Dtd-02.03.2023 at 20.15 hrs while I ASI Amal Kr. Pati along with C/877 Basudev Mahato, C/838 Rakhal Ch. Mahato & NVF/680 Bibhas Mandi were performing NAKA checking duty near at Ladhurka Reliance Petrol pump under Hura PS on NH 60A (Purulia- Bankura) road and acting on source information we detained the above noted person after hot chasing, who was coming from Jambad side towards Ladhurka suspiciously and on seeing Police party he tried to flee away and on searching one iron made improvised country made fire arms (Revolver) having length of 19 cm (approx) with butt, barrel, firing pin, trigger etc has been found and recovered from his exclusive possession kept conceal in his right side waist and on opening the fire arms two live ammunitions were also recovered as being loaded in the fire arms. On being asked he failed to produce any constitutional papers in support of possessing or keeping the fire arms (Revolver). Accordingly I seized the above narrated firearms and ammunition from his possession under proper seizure list (details are mentioned in the attached seizure list) in presence witnesses and also labeled separately in between 20.25 hrs & 20.55 hrs could be made. After seizure I arrested him by observing all the formalities regarding arrest as his offense comes under section 25(1)(a)/27 Arms Act and informed his family member over mobile phone regarding arrest.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under section 25(1)(a)/27 Arms Act and arrange for its investigation.
