Sir,

In producing here with arrested accused persons namely 1) Nirmal Mahato (22) S/O Sahadeb Mahato of Vill- Bon Nutundih, PS-Jhalda, Dist-Purulia , 2) Riyasat Kazi (28) S/O Kalam Kazi of Vill-Hussaindih, PS-Jhalda, Dist-Purulia 3) Baghambar Majhi (23) S/O Narendranath Majhi of Vill- Kiribera,PO-Kalma,PS-Jhalda,Dist- Purulia & 4) Prasanna Majhi (25) S/O Upendranath Majhi of Vill- Kiribera,PO-Kalma,PS-Jhalda,Dist- Purulia and seized articles (i) One Iron Rod length approx 3 ft (ii) One Bhujali attached with Bamboo handle length approx 1.4 ft and sharp edge of Bhujali is approx. 11 inches (iii) one lylon rope in blue colour length approx 20 mtr iv) One Bambo stick length approx 3.5 ft lodged complain against them and 14/15 others 1) Imroj@Moja,2)Bhalka,3)Saddam all of Village Kantadih,PS Jhalda,Dist-Purulia among them to the effect that on 16/03/2023 at about 23.35 Hrs during my night mobile duty received a credible tip that a gang of dacoits being armed with deadly weapons assembled in an abandoned house near Maya Sarabar situated at Jhalda ward no 6 and they were preparing themselves for committing dacoity at Jhalda Town. Subsequently I, informed to you as well as the Duty Officer and as per your direction I asked the duty officer to note the information down in the GDE Vide Jhalda PS GDE No 800 Dated 16/03/2023. On getting the tip off as per kind order myself accompanied with force who were detailed for the Night Mobile Duty with me namely (i) C/2182 Md Safiul Khan (ii) C/1207 Tarit Kr. Majhi (iii) C/1284 Pratapaditya Majhi and (iv) HG/1772 Fatik Ch. Kumar all of Jhalda PS vide CC No. 780 dated 16/03/2023 & vide Jhalda PS GDE NO 791 Dated 16/03/2023 immediately proceeded to the anticipated place of assembly to work out the information and reached near Chack bazar at 23:55 Hrs leaving the Police vehicle No- WB 56M 7939 and started to proceed for the anticipated place on foot. At 00:05 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 18/19 persons assembled under an abandoned house near Maya Sarabar situated at Jhalda ward no 6 and 100 mtr away from Purulia Ranchi road and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up only 04 (Tour) of them at 00:15 Hrs while the rest 14/15 had managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the following articles from the exclusive possession of the respective accused person (i) One Iron Rod length approx 3 ft from the possession of Nirmal Mahato, (ii) One Bhujali attached with Bamboo handle length approx 1.4 ft and sharp edge of Bhujali is approx 11 inches from the possession of Riyasat Kazi (iii) one lylon rope in blue colour length approx 20 mtr from the possession of Baghambar Majhi (iv) One Bambo stick length approx 3.5 ft from the possession of Prasanna Majhi. Subsequently, I seized in between 00:45 hrs to 01:25 hrs on 17/03/2023 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities, (i) One Iron Rod length approx 3 ft (ii) One Bhujali attached with Bamboo handle length approx 1.4 ft and sharp edge of Bhujali is approx. 11 inches (iii) one lylon rope in blue colour length approx 20 mtr iv) One Bambo stick length approx 3.5 ft from the place of assembly under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat. On interrogation they confessed their guilt and they stated that they have assembled there with 14/15 others 1) Imroj@Moja,2)Bhalka,3)Saddam all of Village Kantadih,PS Jhalda,Dist-Purulia among them for committing a house dacoity in a Maru family at Jhalda Town .I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place, so I could not able to accompany with public witness. Under such circumstances it is reasonable to believe that the above noted apprehended



persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those persons after preparing memo of arrest and ground of arrest duly communicated to them. I also note here that when the accused persons try to fled away accused Nirmal Mahato fall down and received injury on his head.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Nirmal Mahato (22) S/O Sahadeb Mahato of Vill- Bon Nutundih, PS-Jhalda, Dist-Purulia , 2) Riyasat Kazi (28) S/O Kalam Kazi of Vill-Hussaindih, PS-Jhalda, Dist-Purulia 3) Baghambar Majhi (23) S/O Narendranath Majhi of Vill- Kiribera, Po-Kalma, Ps-Jhalda, Dist- Purulia & 4) Prasanna Majhi (25) S/O Upendranath Majhi of Vill- Kiribera, Po-Kalma, Ps-Jhalda, Dist- Purulia along with 14/15 others 1) Imroj@Moja, 2) Bhalka, 3) Saddam all of Village Kantadih, PS Jhalda, Dist-Purulia among them under proper section of law.
