In producing here with one arrested accused person namely (i) Mahesh Kuiry S/O- Sudhir Kuiry of Jhalda Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 156 (One hundred fifty six) Pcs sealed bottles of Chlorpheniramine Maleate &Codeine Phosphate Syrup as ONEREEX @ Rs. 154.50/- per bottle, having 100 ml in each bottle from the possession of the accused person mentioned above. I ASI Sisir Kr. Gope of Jhalda PS do here by lodged a written complaint against Mahesh Kuiry S/O- Sudhir Kuiry of Jhalda Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia to the effect that today (19/03/2023) while performing spl. mobile duty (This refers to Jhalda P.S. GDE No- 948 Dt- 19/03/2023, vide C.C. No- 813 Dt- 19/03/2023) near Birshamore. I received an information from my source at about 20:05 hrs that one person, namely Mahesh Kuiry was coming towards Jhalda Town carrying huge quantity of Cough Syrup in a white colour bag for selling clandestinely to the youth customers of Jhalda town area. After having received this information I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I ASI Sisir Kr. Gope along with (i) C/955-Dilip Kr. Mandal, (ii) C/441-Santo Das all of Jhalda PS left Jhalda Railway station immediately to work out the information. We, all reached with Govt. Vehicle near Jhalda Sub-Register office at 20:15 Hrs and found one person going towards Jhalda Town from Sub-Register office, Jhalda Ward No-03 under Jhalda PS with a white colour bag as identical as I received information. Subsequently, I apprehended him at Jhalda Sub-Register office and search and found (i) 156 (One hundred fifty six) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup as ONEREEX @ Rs. 154.50/- per bottle, having 100 ml in each bottle from his bag. On interrogation he disclosed his identity as mentioned above and he also said that he collected these illegal cough syrup from Chas under Jharkhand state. On demand he failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as signed by the apprehended persons and also prepared label with seal and from which 01 (one) bottle of cough syrup was kept as sample and out of which 01 (one) strips is collected as sample. He also disclosed that he along with (i)Sadhan Chandra, (ii) Ajay Chandra, (iii) Madhu Bagdi & (iv) Malay Dutta all of Jhalda Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia was they were running Cough Syrup (illegal drugs) business and he along with others carrying the said syrup for the purpose of selling to the local youth customers. Subsequently, I arrested the accused person namely Mahesh Kuiry S/O- Sudhir Kuiry of Jhalda Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against accused person namely (i) Mahesh Kuiry S/O- Sudhir Kuiry he along with (ii) Sadhan Chandra, (iii) Ajay Chandra, (iv) Madhu Bagdi & (v) Malay Dutta all of Jhalda Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia U/S 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
