

## Most Respectfully sheweth:

- 1. That the complainant of this case namely Biplab Kayal s/o, late Madhu sudan Kayal of Jhalda poddar para word no -9, who is selected as a president of the special meeting of board of councillors for election of the chairman, Jhalda municipality dated 16/1/2023 and the place of occurrence is Jhalda municipality therefore the jurisdiction falls under this Ld.Court
- 2. That as per order of the Hon'ble High Court , Kolkata dated 13/1/23 a special meeting was held in Jhalda municipality office on 16/1/23 for election of Chairman.
- 3. That it was directed by the Honorable High Court to held the meeting under the strict supervision of District Magistrate, Purulia. And the SDO Jhalda sub division was assigned by the DM to act as his representative.

  Accordingly the election process was started at 11:00am on 16/1/23.
- 4. That the defacto complainant was elected as the president of the said meeting .
- 5. That all the councillors except Mr Suresh Kumar Agarwal councillor ( word no 6) collected ballot paper from the defacto complainant individually in order to cast their vote but surprisingly four TMC Councillors namely Mr. Sudip karmakar councillor (word no 5), Smt. Purnima Bagti councillor (word no 11), Smt. Joba Machuwar Councillor(word no 10), Smt. Rizwana Khatun, Councillor (word no 7) walked out from the voting hall with the ballot paper without casting their votes
- 6. That the defacto complainant repeatedly requested the accused to caste their votes but failed .





- 7. That the defacto complainant then requested the SDO

  Jhalda sub division to take action to recover the ballot
  from the accused persons but SDO Jhalda sub -division also
  remained silent.
- 8. That all the accused persons with their common intention conspire and extorted the voting ballot papers with the intention to violate court orders of Hon'ble High Court and apply criminal force in presence of SDO Jhalda sub-division to deter public servant from discharging of his duty and applied criminal force on grave provocation and used some filthy languages and threatened the president of the said meeting i.e , the defacto complainant of this case .
- 9. That the accused persons have committed such kind of incident in presence of SDO Jhalda sub-division and other councillors of Jhalda municipality, and the president of the said meeting along with all other councillors are the eye witness of the said incident.
- 10. That the defacto complainant lodged this complaint to the concerned PS on 16/1/23 but the IC Jhalda PS did not take any action against the present accused persons nor he lodged any FIR in respect of the said complaint, then on 19/1/23 the complainant further informed to the SP purulia through e-mail but till date no action had been taken. So the defacto complainant preferred to file this petition before your honour u/s 156(3)CrPC for necessary consideration.

It is, therefore, most respectfully prayed that Your Honour may graciously be pleased to accept this petition and sent this complaint to the then LC Jhalda PS for lodging FIR and take necessary action in accordance with law
