Sir,

In producing herewith one arrested accused person namely Anil Majhi (50 yrs) S/o-Late Shibaram Majhi of Vill- Jahajpur PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizure list i.e. one white colour polythene Jarkon containing approx 10 (ten) liter Illicit liquor (locally known as Mohalla).

I SI Mahadeb Rana of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today 05/03/2023 at about 14:25 hrs when myself along with SI Manoj Kumar Panda, NVT-860 Suryakanta Mahato HG/-1717 Phanibhusan Mahato, were performed Special mobile-II duty vide Joypur PS C.C. No-551/2023 Date-05/03/2023, as per my source information I reached at Joypur Forest Check-post mark under Joypur PS and found that the above noted accused person selling illicit liquor (Mohalla) on the road. On seeing Police person, he concealed his presence at that place, but on searching we able to trace out him and also to found that 10 (ten) liter of Illicit Liquor (locally known as Mohalla) which was carrying by hand. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling illicit liquor to the local people in the area. On demand he failed to produce any valid documents in respect of selling such illicit liquor (Mohalla). So, it is reasonable to believe that he was selling the Id liquor (Mohalla) illegally without any documents. So, I seized the same under proper seizure list in between 14:25 hrs to 15:00 hrs & label duly signed by him and other available witness after taking 600 ml as sample in a separate bottle.

During further interrogation he confessed his guilt as such I arrested Anil Majhi (50 yrs) S/o-Late Shibaram Majhi of Vill- Jahajpur PS-Joypur, Dist-Purulia today 05/03/2023 at 15:05 hrs as the accused person is liable for prosecution U.S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Anil Majhi (50 yrs) S/o-Late Shibaram Majhi of Vill- Jahajpur PS-Joypur, Dist-Purulia U.S-46A (c) of the Bengal Excise Act 1909.
