


Most respectfully Sheweth :-

- That both the parties are the resident of Joypur,
 P.S. which is under your Jurisdiction.
- 2) That the complainant i.e. your petitioner was married with the accused No.-1 on 19/01/2018 at their residence, as per the Hindu marriage Act, Shastras and customs prevelant in their society, in presence of all the relatives, friends of both the parties.
- 3) That as per the demand of the exaccused persons cash of Rs. 50,000/- plus Rs. 80,000 /- for Motor Cycle Almirah, Palank, Utensils, etc. was handed over to them, by the father of your petitioner at the time of marriage.
- 4) That after marriage your petitioner reached her matrimonial house and started living with her husband i.e.



accused No.1 peacefully.

- 5) That after some days of the marriage your petitioner realised that the accused husband was a habitual drunker. Drug addicted and loose in character. He used to maintain an illicit physical relation with other girl.
- 6) That when ever your petitioner protested against his such immoral activities, he used to torture your petitioner both physical and mental and other accused persons also used to support this kind of torture more over they also used to join hands.
- 7) That the accused husband used to go out of state for seeking private Job and during this period, the mother-in-law, father-in-law and sister of the husband i.e. accused no.2,3 and 4 used to increase the degree of torture upon her by beating her mercilessly as and when they wanted and also used to keep her without proper food etc.
- 8) That after some days, when the accused husband returned, all the accused persons directed her to bring fifty thousand rupees for starting a business and on the denial of doing so by your petitioner they tortured her bruitally.



- 9) That on 28/08 /2020 the accused husband being accompanied by some of his Drunker friend, and the Elected member of the locality, very forceibly took your petitioner to her father's house and put her their saying that there would be no relation with her and the accused husband declare that he was going to merry a girl having a handsome amount "DAHEJ".
- 10) That your petitioner again followed them to her matrimonial house, but the accused husband closed the door and did not allow her to enter the room, your petitioner waited there till deep night but the accused husband did not open the door lastly her father took her to his house.
- 11) That from that day i.e. 28/08/2020 your petitioner has been living with her father.
- 12) That the accused husband did not allow your petitioner in his bed and as a result birth of any child was not possibel.
- 13) That recently your petitioner collected report that the accused husband very shortly will be married with a new girl.
- 14) That on 10/02/2023 your petitioner lodged a compain before the I.C. joypur police, vide registered post as her previous complain w as unallended, but this time also joypur police did not take any step.



- 15) That finding no other way, your petitioner submitted a complein before the s.p. Purulia on 14/02/2023 but to no effect.
- 16) That all the accused person in a joint hands committed torture, thrown her out of have and moreover they all are going to arrange marriage of the victim husband on 11/03/2023 26th falgun with a girl D/o. Jiten Mahato @ Jitu of a nearby village Senabena, Arsha, P.S. as per information from a reliable source.
- 17) That thus all the accused persons are punishable under appropriate section of law for their inhuman, illegal activities, committed will a planned conspiracy.

In these grawd situation it is therefore, prayed that your honour would graciously send this petition before the I.C. Joypur, P.S. with a direction to treat this as F.I.R. as contemplated U/s. 156 cr.pc. and to prevent the possible marriage of the accused husband after investigation and also to register a case against all the accused persons to make them face trial in open court.
