On, 19/03/2023, in middle of the night, some unknown people broke the ventilator window shield and tried to set fire to the diagnostic set-up with some inflammable articles. In the morning of that day wrecked window shield were found along with broken & Burn USG machine and online ups machine.

Jaipur police station was informed about this matter immediately and primary inspection was done on that day at 10:30 a.m.

Two persons are suspect in this incident are MILAN KUMAR & MEGHNATH KUMAR (Near Vendor of USG Centre) because various types of threats were found before from that end.
