The above named complainant begs to state as follows:-

1----That your petitioner , the witnesses and the accused persons are the residents of the same village Chapaitar under P.S. Joypur , District Purulia .

2----That the father of your petitioner and his co sharers are the actual owners of the lands situated in Mouza Chapaitar and Uparkahar and recorded in R. S. Khatian Nos. 320 and 65 in the names of Nagendranath Mahato and Hare Krishna Mahato sons of late Duryodhan Mahato and are in physical possession of the same by the father of your petitioner.

3----That Duryodhan Mahato , grand father of the complainant expired leaving behind two sons namely Hare Krishna Mahato and Nagendranath Mahato and four daughters namely Kalita Mahato, Lalita Mahato Kumudi Mahato and Chhutumiya Mahato as his legal heirs and successors . The said Hare Krishna Mahato while was in ownership and possession of the lands situated in Mouza Chapaitar and Upar Kahan , he gifted his entire shares to his full brother Nagendranath Mahato vide Regd. Deed of Gift dated 26-02-2008 and delivered possession of the same to him .

4----That aforesaid Hare Krishna Mahato had four wives namely Anjana Mahato , Mini Mahato , Shalu Mahato and Pabita Mahato . Anjana Mahato had two daughters namely Chana Mahato and Urmila Mahato through Hare Krishna Mahato . After the birth of Chana Mahato and Urmila Mahato Ajana Mahato expired . Aforesaid Mini Mahato expired issueless . The third wife of Hare Krishna Mahato is Shalu Mahato who still alive . During the life time of Shalu Mahato Hare Krishna Mahato contracted 4th.mariage with one Pabita Mahato . Said Pabita Mahato has a daughter Sujata Mahato through Hare Krishna Mahato .

5----That said Hare Krishna Mahato died on 06-10-2012, leaving behind his third wife Shalu Mahato, fourt wife Pabita Mahato ans three daughters namely Chana Mahato, Urmila Mahato and Sujata Mahato as his heiress. After the death of Hare Krishna Mahato his two wives Shalu Mahato and Pabita Mahato and three daughters Chana Mahato, Urmila Mahato and Sujata Mahato have jointly inherited the properties left by Hare Krishna Mahato.

6----That the accused persons in order to grab the properties left byDuryodhan Mahato and Hare Krishna Mahato and in order to deprive the legal heirs of late Hare Krishna Mahato and his Duryodhan Mahato , hatched a plan and entered in to a criminal conspiracy to one another accused Sujata Mahato in collusion with accused No. 2 and 3, sworn a false affidavit of legal heirs of late Hare Krishna Mahato and Duryodhan Mahato on 10-11-2021 , before Mr. Korim Box , the Judicial Magistrate .4th. Court Purulia and in the said affidavit she claimed herself and her mother Pabita Mahato are the only legal heirs of late Hare Krishna Mahato and Duryodhan Mahato by suppressing the name of other legal heirs of Hare Krishna Mahato Duryodhan Mahato .

7---That , it may be mentioned here that accused Surapati Mahato is a police man and posted as a Constable at Joypur Police Station by exercising his official capacity before the office of the B.L. & L.R. O. Joypur and by producing the said legal heir affidavit and in collusion with the Revenue officer have got recorded the entire properties in the names of accused Sujata Mahato and Pabita Mahahto, left by Duryodhan Mahato and Hare Krishna Mahato for wrongful loss of the father of the complainant and the other legal heirs of Duryodhan Mahato and Hare Krishna Mahato and wrongful gain of the accused persons . After recording their names the accused persons declared in the village that they have recorded the entire lands of Mouza Chapaitar and Upar Kaan left by Duryodhan Mahato and Hare Krishna Mahato .

8----That thereafter the complainant and other legal heirs of Hare Krishna Mahato and Duryodhan Mahato enquired about the alleged recording in the names of the accused persons and come to learnt that the accused persons have got recorded their names in the office of the B.L. & L.R. O. Joypur on the strength of the said affidavit of legal heirs of Duryodhan Mahato and Hare Krishna Mahato .

9----That it is crystal clear that the above accused persons after making conspiracy with one another by suppressing the truth , the above named accused persons are the only legal heirs of Duryodhan Mahato and Hare Krishna Mahato cheated the actual legal heirs and by cheating the ld. Magistrate and stuffs of the office of the B.L. & L.R.O. Joypur have got recorded the entire properties in their names by suppressing the truth and actual affairs .



10----That due to such conspiracy and suppressing the facts there has been wrongful loss to the father of the petitioner as well as the other legal heirs of deceased Duryodhan Mahato and Hare Krishna Mahato , whereas there been wrongful gain of the accused persons in furtherance of their common intention have cheated the father of your petitioner and grabbed the properties ..

11----That there after your petitioner informed the matter to the local police station . The duty officer assured your petitioner to take legal action against the culprits but no specific case has been started against the accused persons by the police best known to them . Again your petitioner and his P.W.s went to police station to enquire about the fate of his complaint .

12---- That your petitioner believes that the accused Surapati Mahato is the stuff of the local police station and have much influence upon the police and so the police is evasive in the matter and did not take any legal action against them . There after your petitioner knocked the door of the Superintendant of Police Purulia on 17-11-2022 ,but nothing has been done by his good office

13----That your petitioner is a helpless and poor man having no source of income . He is not in a position to pull the case in his own cost . Moreover , there are some technical and legal aspect involved in this case which also requires considerable money and machinery .So, it is highly desirable that this case should be converted to a Police case .

It is prayed that your Honour may be graciously pleased to direct the Officer in Charge Joypur Police Station to investigate the case in accordance with law treating the same as F.I.R. as contemplated U/S 156 (3) Cr.P.C.
