In producing herewith one arrested accused person namely Chittaranjan Mahato (45 yrs) S/o-Srikanta Mahato of Vill-Jibandih PS-Pindrajora Dist-Bokaro State-Jharkhand under arrest along with seized articles as per seizer list i.e. (1) 15 (Fifteen) Bottle of country spirit each of 600 ml styled as "DILSE" (2) 02 (two) bottle of country spirit each of 750 ml styled as "OFFICER CHOICE" grand whisky (3) one Motor Cycle (Splender+ grey Black Colour) having Registration No-JH09AR-8630 under proper seizure with label.

I ASI Swapan Mandal of Joypur PS hereby lodged a written complaint against the above noted accused person, to the effect that on (23-24/03/2023) at about 21:35 hrs during my anticrime Naka checking duty at Kathaltard, myself along with C/-1177 Samir Das, C/-1345 Jitendranath Diasi, C/-1356 Rajib Kundu all of Joypur PS that one person namely Chittaranjan Mahato (45 yrs) S/o-Srikanta Mahato of Vill-Jibandih PS-Pindrajora Dist-Bokaro State-Jharkhand was coming from Chas morh side by driving one Motor Cycle (Splender+ grey Black Colour) having Registration No-JH09AR-8630 with carrying (1) 15 (Fifteen) Bottle of country spirit each of 600 ml styled as "DILSE" (2) 02 (two) bottle of country spirit each of 750 ml styled as "OFFICER CHOICE" grand whisky for the purpose of selling the same and detained him. I immediately informed the matter to IC of the PS and as per his direction and intercepted the above noted Motor Cycle JH09AR-8630 and person, who was driving the same. I searched the Motor Cycle and the person thoroughly and physically and on search found the above noted ID liquor. On demand he failed to produce any license / authority of the said liquor. He also failed to produce any paper in respect of the Motor Cycle as well as driving license. On interrogation he also made incoherent statement regarding possession of said liquor and told that he will sell the same in the local villagers illegally. So, finding no any other alternative I seized (1) 15 (Fifteen) Bottle of country spirit each of 600 ml styled as "DILSE" (2) 02 (two) bottle of liquor each of 750 ml styled as "OFFICER CHOICE" grand whisky and one Motor Cycle (Splender+ grey Black Colour) having Registration No-JH09AR-8630 above noted articles from the possession of the accused and labeled, duly singed by the accused person & witnesses on 24/03/2023 at 05:05 hrs to 05:25 hrs in which one bottle of liquor i.e. one bottle was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Chittaranjan Mahato (45 yrs) S/o-Srikanta Mahato of Vill-Jibandih PS-Pindrajora Dist-Bokaro State-Jharkhand U/S-46A (c) of the Bengal Excise Act 1909.
