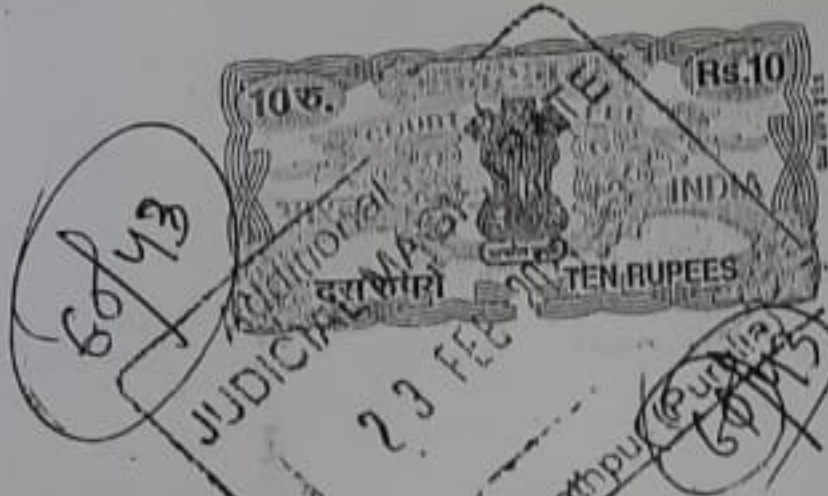

Offence under :- 420, 406, 427, 511, 120 B of I.P.C.

Application under Section :- 156 (3) of the Cr. P.C.

Complainant named – aboved most respectfully begs to state :-

1. That the Complainant is a senior citizen of India and he is an inhabitant of Kashipur, P.S.- Kashipur, Dist –Purulia.
2. That one civil suit bearing title suit no 16 of 2017 pending in the Ld. Civil Judge(Jr. Divn) at Raghunathpur, in connection with the "Janata Tokis" cinema hall and said title suit has filed by this complainant against the Accused person no. 1 and others for declaration his right, title against the suit property.
3. That on 23/09/2022 the Accused person no. 1. Transferred the property of " Janata Tokis" cinema hall to Anima Beltharia, W/O – Swapan Kumar Beltharia by suppressing the fact of pending civilsuit and he transferred Anima Beltharia and thereafter on 31/10/2022 Accused person no 1. With the help of some miscreants forcibly broken, some portion of " Janata Tokis" cinema hall, on raises objection by the complainant, the accused person threatened him and used to Rough languages upon the complainant.
4. That the accused person damage the " Janata Tokis" cinema hall of the complainant and for that complainant monetary suffers loss of about Rs. 5,00,000/- (Five lacs) and the Accused person no 1 transferred the " Janta Tokis "cinema hall by suppressing the actual facts and they illegally transferred the cinema hall, the accused person. 1 intentionally, illegally and also forcibly taken some portion of cinema hall and they cheated the complainant .

5. That for the illegal and irregular acts of the accused person this complainant has been cheated by the accused person no . 1 and he also suffered loss of Rs. 5,00,000/- (Rupees Five lacs).
6. That the accused person no. 1 with conspiracy intentionally cheated the complainant and they also intentionally damaged the complainant's cinema hall and for that reason accused person fraudulently prepared the sale deed and transferred fraudulently and fraudulently prepared L.R.R.O.R in the name of Anima Beltharia , W/O – Swapan Kumar Beltharia, by criminal breach of trust.
7. That the complainant lodged written before the office-in – charge, Kashipur through registered post on 02/11/2022 and further he intimated through written complainant by registered post on 07/11/2022 Dist. Superintendent Of Police Purulia.
8. Thereafter Kashipur P.S. Officer In-Charge was advised me to file a complainant before the LD. A.C.J.M Raghunathpur for proper adjudication.
9. That for non-taking proper steps by Police against the Accused persons, this complainant file this complaint before this Ld. Court, at the place of assurance within the jurisdiction of this Ld. Court.

Therefore , it is prayed that your honor would be graciously pleased enough to accept this complaint and to send this complaint petition to the office-in-charge, Kashipur Police Station U/S. 156(3) of the Cr.P.C. for treating the same as FIR and directing the Officer-in-Charge to take cognizance against the accused person.
