Sub: To lodge FIR against owner and driver of 01 (One) tractor i.e. Sonalika DI 35RX (Blue Colour) tractor having Registration No WB 55A 2124, Chassis No – BYASV32621653, Engine No – 3100FLS23L323933F2, along with trolley (without number plate) loaded with sand approx 70-75 Cft.

Sir,

In producing herewith, (i) 01 (One) tractor i.e. Sonalika DI 35RX (Blue Colour) tractor having Registration No WB 55A 2124, Chassis No – BYASV32621653, Engine No – 3100FLS23L323933F2, along with trolley (without number plate) loaded with sand approx 70-75 Cft. (ii) 02 pieces old Iron made "Belcha" having iron butt and (iii) 02 pieces iron made "Dhama" before you

The nub of the fact in a nutshell is that today on 14.03.2023 at 16.15 hrs I, SI Gourango Roy of Kashipur PS along with (i) C/850 Tarak Nath Mandal and (ii) C/869 Pradipta Ratan Ghosh both of Kashipur PS, Dist - Purulia, left the PS for performing anti crime evening mobile duty at Kashipur P.S area vide Kashipur P.S GDE No – 588 Dtd – 14.03.2023 and C.C No. 726/23 Dtd. 14.03.2023. During my mobile duty, I received a tip off at 18.05 hrs. that some persons were loading some tractors with sand from the river bed of Darkeswar River near Talgora ghat under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of a tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley), fled away from the spot. We rushed to the Tractor and detained the tractor. We searched the tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of the offending Tractor. Hence, I seized (i) 01 (One) tractor i.e. Sonalika DI 35RX (Blue Colour) tractor having Registration No WB 55A 2124, Chassis No – BYASV32621653, Engine No – 3100FLS23L323933F2, along with trolley (without number plate) loaded with sand approx 70-75 Cft. (ii) 02 pieces old Iron made "Belcha" having iron butt and (iii) 02 pieces iron made "Dhama" under proper seizure list in between 18.45 hrs and 19.05 hrs, also brought the said seized articles to Kashipur PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted seized tractor along with the trolley for investigation.
