Respected Sir,

In producing herewith the seized vehicle (Tractor) bearing Engine No- RKK2EAN0112, Chassis No – MBNABAEXKKRK01571 attached with Trolley without number plate loaded with sand approx. 100 cft . The fact of the case in brief is that on 21/03/2023 I along with C/808 Soumen Bangal and C/812 Tanmoy Kundu both of Kenda PS were performing night mobile duty. During night mobile duty on 22/03/2023 I, received source information that some persons are lifted sand from Kansai riverbed near Guguitard village under Kenda PS by illegal means. Then I informed the matter to O/C Kenda PS and left to work out the information and at about 06.05 hrs. when we reached at Kansai riverbed near Guguitard village found that the above noted tractor was being loaded by some persons. Seeing the Police party driver of the said vehicle and other persons fled away from there leaving the vehicle (Tractor). We chased them but could not apprehend. I contacted with BL & LRO, Puncha and he informed me that there is no Govt. Lease/Permission in respect of that riverbed area to lift sand as per Govt. rules. So, there is every reason to believe that the sand was lifted there by those persons in an illegal way. I placed guard there and held local enquiry at Guguitard village. It was known from the local available people that (i) Ratheswar Mahato @ Rathu (ii) Pankaj Mahato both of vill- Suridih PS-Puncha Dist-Purulia and (iii) Laltu Mahato, (iv) Mahadeb Mahato both of Vill- Bansa, PS- Kenda, Dist- Purulia and other unknown persons and the driver and owner of that vehicle are running their clandestine business making a racket for more than 02 (Two) months and it is causing loss of huge amount of Govt. revenue day by day. Those persons are habitual offender in respect of lifting, selling, possessing of illegal sand from that riverbed and are making profit dishonestly causing loss of huge amount of Govt. revenue.

Thereafter, I seized the tractor bearing Engine No- RKK2EAN0112, Chassis No – MBNABAEXKKRK01571 attached with Trolley without number plate loaded with sand approx. 100 cft . under preparing proper seizure list in presence of available witnesses duly signed by them and arranged to brought it to Kenda PS.

So, I do hereby lodged a complaint against driver and owner of the tractor bearing Engine No- RKK2EAN0112, Chassis No – MBNABAEXKKRK01571 attached with Trolley without number plate loaded with sand approx. 100 cft and (i) Ratheswar Mahato @ Rathu (ii) Pankaj Mahato both of vill- Suridih PS-Puncha Dist-Purulia and (iii) Laltu Mahato, (iv) Mahadeb Mahato both of Vill- Bansa, PS- Kenda, Dist- Purulia and other unknown person with a request to start a case under proper section of law and also for it's investigation.
