Sub: Complaint against Bhim Sen Kumar (31 yrs), S/O Dinabandhu Kumar of Vill- Basti Kotshila , PS- Kotshila, Dist-Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. Bhim Sen Kumar (31 yrs), S/O Dinabandhu Kumar of Vill- Basti Kotshila , PS- Kotshila, Dist-Purulia with seizure of approx 10 (Ten) liters illicit liquor (Cholai) from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (05.03.2023) during Spl. mobile duty on acting secret source information I held raid 17:05 hrs in the house of above noted person at Basti Kotshila village who was stocked illicit spirit in his house. I searched the place and found approx 10 (Ten) Liters illicit spirit which was kept in a white colour Jaricane. On interrogation he disclosed his name and address as noted above and also stated that he uses to sell the same for his gain in lieu of money. On demand he failed to produce any valid documents in respect of illicit spirit which was kept in his house. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith in between 17:15 hrs to 17:35 hrs. As such he was arrested at 17:45 hrs U/S- 67 B.E. Act and during arrest the ground of arrest was duly notified issuing arrest memo U/S- 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 500 (Five Hundred) ml. was taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Bhim Sen Kumar (31 yrs), S/O Dinabandhu Kumar of Vill- Basti Kotshila , PS- Kotshila, Dist-Purulia violated the provision of section 18 (i) B.E. Act. for possessing and selling of illicit spirit without obtaining license from a licensing vendor and in contravention, he Committed an offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid C/983 Radhakanta Kisku & C/326 Chandan Kr. Dinda accompanied me Vide Kotshila P.S Spl. C.C No 86/2023, Dated 05.03.2023.

Under the fact and circumstance I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against arrested accd person namely Bhim Sen Kumar (31 yrs), S/O Dinabandhu Kumar of Vill- Basti Kotshila , PS- Kotshila, Dist-Purulia.
