In producing here with an arrested accused namely Prasenjit Kumar @ Prasenjit Kumar Pal (22 yrs) s/o Lt. Karam Kumar Pal of vill.- Durgu, PS-Kotshila, Dist-Purulia with seized articles (i) one improvised country made fire arms (Iron made) length in total 11 inch (Approx) (Butt - 3.5 inch, Body - 2.5 inch & Barrel- 05 inch) having wooden butt, body, barrel, trigger, firing pin etc and (ii) 03 (three) rounds 8 mm live ammunitions marked as 'KF" under proper seizure list duly signed by the witnesses. I ASI Pankaj Kumar Gupta of Kotshila PS beg to inform you that today (26.03.2023) I along with force namely C- 1534 Krishna Ch Mahato and C- 1333 Dilip Kr. Mahato of Kotshila PS were performing Anti Crime Mobile duty at Kotshila Bazar vide Kotshila PS GDE No. 996 Dtd. 26.03.23 corresponding CC No. 784/23 Dtd. 26.03.23 and at 21.15 hrs Duty Officer SI Purnendu Datta received an information that one person was moving suspiciously with a fire arms near Baman Bandh on Tali Center-Barahankal village road. Accordingly he diarised the matter vide Kotshila PS GDE No.1005 Dtd. 26.03.23 and informed to O/C Kotshila PS and as per direction of O/C Kotshila PS he inform me to work out the information. Accordingly I along with force left for Barahankal side under Kotshila PS to work out the information. At 21.45 hrs myself along with force arrived near Baman Bandh on Barahankal-Tali Center village road found that one person was moving suspiciously and seeing the police party he tried to fled away. After a hot chase we could apprehend him and asked him about his identity and he disclosed his identity as noted above. I asked him why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one improvised country made fire arms (Iron made) length in total 11 inch (Approx) (Butt - 3.5 inch, Body - 2.5 inch & Barrel- 5 inch) having wooden butt with black tape, body, barrel, trigger, firing pin etc with 03 (three) rounds 8 mm live ammunition marked as "KF" which was kept in left side of the waist concealed under the shirt of Prasenjit Kumar and out of three round ammunition, 01 (one) round loaded in the barrel and rest 02 (two) rounds kept separately in left side pocket of the pant of Prasenjit Kumar @ Prasenjit Kumar Pal. On demand he was unable to produce any valid documents/license in respect of keeping such arms & ammunitions; neither could give any satisfactory explanation in respect of carrying such arms ammunitions. It appeared he possessed those either to sell or to commit any crime. I unload the ammunition from the said improvised arms after taking all precaution and seized the said arms and ammunitions with proper seizure list and also the seized arms and ammunitions packed, sealed and labeled in presence of police witnesses as no public witness was available there. The seizure was made in between 22.25 hrs and 22.45 hrs. Hence I arrested him at 22:55 hrs as he has committed an offence which is punishable U/S 25(1)(a) of The Arms Act 1959.

Hence I pray to start specific case against arrested accused person namely Prasenjit Kumar @ Prasenjit Kumar Pal (22 yrs) s/o Lt. Karam Kumar of vill.- Durgu, PS-Kotshila, Dist-Purulia U/S 25(1)(a) of The Arms Act 1959.
