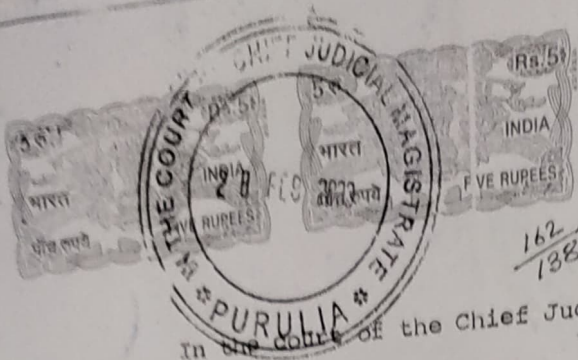

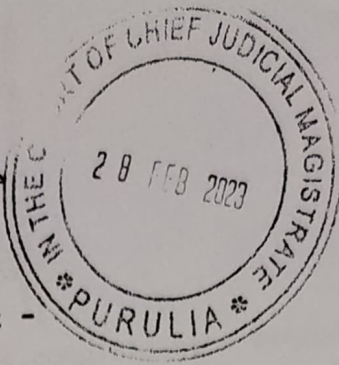

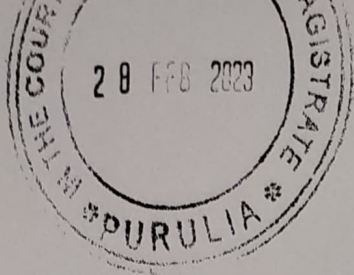

The humble petition u/s.156(3) Cr.P.C.

Most respectfully begs to state as follows:-

1. That petitioner as well as the accused persons are inhabitants of Vill.Nadiara, under Purulia(M) P.S., Dist.-Purulia within the jurisdiction of the court.
2. That your complainant on several time went to the P.S.to lodged a written complaint in respect of cheating and forgery by the accused named above;but the P.S.denied to accept the same and then petitioner sending it through register post but nothing has been done then your complainant lodged a complaint before the S.P.Purulia but of no good as such your petitioner compelled to file this complaint petition in u/s.156(3) Cr.P.C.and as most of the witnesses [✓]one official staff as such investigation of police is highly required.
3. That late Gangadhar Paramanik (father of complainant) Rakhahari Paramanik (uncle), Padmabati Paramanik [✓](aunt) and Sarala Paramanik (grand mother) was the owner of the property being [✓]R.S.Plot No.1853, khatian no.50 J.L.No.74 total area 16 decimals.

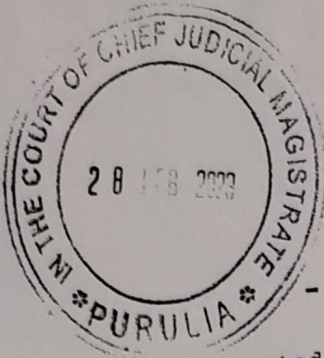

4. That in the year 1974 complainant's father Gangadhar Paramanik alongwith other co-sharers sold 6 decimals of land from R.S.Plot No.1851 and 4 decimals of land from R.S.Plot No.1852 total 10 decimals of land from aforesaid two plots to Hanu Ansary of Vill.Nadiara, vide deed no.11860.

5. That here be it mentioned that accused persons claiming that wife of Rakhahari Paramanik sold 9 decimals of land to the grand father of the accused persons ^{but} the complainant and co-sharers possessing entire 16 decimals of land in R.S. Plot No.1853.

6. That all the accused persons are son and grand son's of late Hanu Ansary and for the purpose of wrongful gain of the accused and wrongful loss of complainant and their co-sharer committed forgery by deleting R.S.Plot No.1852 to convert it as 1853 and of which area was 4 decs by deleting and altering it and by writing it as 6 decimals and in R.S.Plot No.1851 which was 6 decimals through manipulation converted it as 4 decimals in the certified copy of Deed No.11860 placed it before the B.L.& L.R.O.Purulia-1 and mutated R.S. Plot No.1853 area 6 decimals and 1851 area 4 decimals instead of original 1851 area 6 decs and 1852 area 4 decs.

7. That on 18.1.23 your complainant came to know through notice of B.L.& L.R.O.Purulia-1 that the land of R.S.Plot No.1853 area 6 decimals and R.S.Plot No.1851 area 4 decimals

all the accused mutated their names by suppressing forged manipulating certified copy of deed vide no.11860 and in original certified copy it has been mentioned ^{as} 1851 area 6 decimals, 1852 area 4 decimals but the accused persons committed forgery by preparing, tempering and manipulating documents ~~deleting~~ the original plot no. and then your complainant taking the xerox copy of same went to the P.S. but P.S. did nothing, then the complainant informed the matter to the S.P. Purulia but till date nothing has been done for ^{altering} of the public documents for the purpose of ^{cheating} and they used it to change the record of right by submitting B.L. & L. R.O., Purulia-I.

8. That the accused committed offence of cheating u/s. ^{420/467/468} I.P.C. and to bring the ^{actually} ~~finally~~ govt official will be required as witness to establish the truth hence 156(3) Cr.P.C. is highly required.

It is therefore prayed that your Honour may graciously be pleased to pass necessary order to investigate the matter after treating it as F.I.R. and the wrong ~~done~~ ^{done} be punished for the ends of justice.
