Respected Sir,

In producing herewith one accused person namely Dhananjay Mahato (35 Yrs) S/o Late Falguni Mahato of Vill- Belma Mandop Para, PS-Purulia (M), Dist-Purulia under arrest and the following seized article under seizure list enclosed herewith:

- 1) Sixteen (16) sealed plastic bottles (CS) containing 600 ml each and labelled with DILKHUSH.

I ASI Partha Sarathi Murmu of this PS do hereby lodge this complaint regarding that today (09.03.2023) at about 15:05 hrs during my day Mobile duty in PS area vide Purulia (M) PS C.C No. 764/23 Dtd: 09.03.2023 received source information over telephone that the above noted accused person has been selling CS liquor illegally and clandestinely from the house of the accused at Belma village under Purulia (M) PS. On receiving the reliable source information, I communicated with you over telephone and as per your instruction I along with C/178 Tulsi Mahato & C/321 Tulsidas Roy of Purulia (M) PS rushed to the spot to work out the information. On arriving to the spot at 15:25 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly, I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party and accused person in the seizure list and the label in between 15:35 hrs to 15:55 hrs. One bottle 600ml liquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness & accused person on seizure list and label. After this I arrested that accused person namely Dhananjay Mahato (35 Yrs) S/o Late Falguni Mahato of Vill- Belma Mandop Para, PS-Purulia (M), Dist-Purulia after preparing proper memo of arrest at 16:05 hrs.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against noted above accused person under proper section of law and arrange for investigation.
