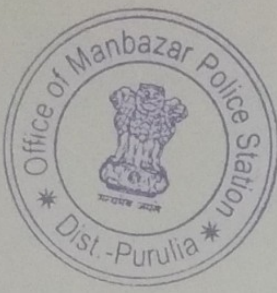

Sir,

In producing here with one arrested accused person Kapil Dey (38), S/O Laxmi Kanta Dey of village- Patharmohara, PS- Manbazar, Dist- Purulia along with following seized articles viz-

(1) 16 (Sixteen) bottles M.C Dwell's No.1, Luxury, each bottle contains 180 M.L.

I S.I. Sanjib Kr. Chatterjee of Manbazar PS do here by lodged a complaint against accused namely Kapil Dey (38), S/O Laxmi Kanta Dey of village- Patharmohara, PS- Manbazar, Dist- Purulia that today i.e. on 06.03.2022 at 19:15 hrs. I received a telephonic information from a reliable source that one Kapil Dey S/O Laxmi Kanta Dey of village- Patharmohara, PS- Manbazar, Dist- Purulia stocked foreign liquor illegally at his road side shop and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/786 Suchand Mandi, C/844 Tufan Soudagar rushed to the spot. At about 19:35 hrs. myself along with force reached at Patharmohara village morh and held raid in the grocery shop shield on 'Soila Bhandar' of Kapil Dey and found that 'Soila Bhandar' owner is selling foreign liquor at his own shop('Soila Bhandar') Seeing the police party some persons fled away and said Kapil Dey tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling foreign liquor, but he failed to produce any valid license or documents for possessing / selling the same. Finding no other alternative I seized the above noted articles under proper seizure list duly signed by accused person and available witnesses. Also arrested the above noted accused person informing him the ground of arrest and observing all legal formalities.

I therefore pray that a specific case may kindly be started against arrested accused person Kapil Dey S/O Laxmi Kanta Dey of village- Patharmohara, PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
