Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Ajit Singh Sarda S/O- Sri Jaladhar Singh Sarda of Village- Pirargoria, P.O- Pirargoria, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 17.03.2023 at about 11:30 am, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Sri Ajit Singh Sarda, S/O- Sri Jaladhar Singh Sarda of Village- Pirargoria, P.O- Pirargoria, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from nearest LT OH line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) 2 nos 100 watts bulb
- 2) 1 nos .80 watts fan
- 3) 2 nos .9 watts CFL

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 11:40 am on dated 17.03.2023. The accused person has committed an offence U/S 135(1)(a) of the Electricity ACT 2003 (Amendment) Act-2007.
