Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sri Tribhanga Bauri, S/O- Satish Bauri**, a permanent resident of **Vill- Natundih P.O -Digha, P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **03.03.2023** at about **11:30AM** I, Sri Dhritiman Sardar S/O- Sri Rupal Sardar, aged about 25 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II), Saltore CCC, Goutam Kr Pandey, HgTSH, Saltore CCC and others had been to the village: Natundih for routine inspection purpose. During inspection it was found that **Sri Tribhanga Bauri** was consuming electricity dishonestly and unauthorisedly in his domestic premises having GPS co-ordinates 23.6441461, 86.7914298 by the way of direct hooking for from the nearby LT mains of WBSEDCL so that less energy consumption recorded in energy meter which resulted causing loss of revenue of WBSEDCL in respect of **Consumer ID-202147178 ,Meter NO-DDG451335** to the tune of load **0.400KVA**.

As theft of electricity was detected during inspection the illegal hooking line is disconnected & removed from the nearby electrical source and one number black coloured 2.5 sqmm copper conductor PVC cable along with hooking devices of assorted size has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list but the accused person denied by putting his signature in the Notice, Seizure List, Inspection Report and label. The above seized materials duly packed and labeled at the inspection site and signed by the WBSEDCL representatives, but the accused person refrain to sign the same. The inspection team left the aforesaid premises at about **11:50AM**.

Thus the accused **Sri Tribhanga Bauri, S/O- Satish Bauri, Vill- Natundih P.O - Digha P.S -Neturia, Dist- Purulia** have committed an offence u/s 135(i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
