Sub:- Complain for starting a specific case.

Sir.

In producing herewith one arrested accused person namely Sunil Murmu (47 yrs) s/o Lt. Baburam Murmu of vill- Chhoto dighari, P.O - New town, PS Hirapur, Dist- Paschim Bardhaman (driver of the vehicle JH 10 AZ 3914) along with the seized 10 wheeler Hyva Dumper having registration No- JH 10 AZ 3914 loaded with sand approx 700 Cft under proper seizure list. I beg to submit that I, SI Banshilal Mahato, along with C/159 Dinesh Sardar, C/1550 Bharat Ghosh and NVF 578 Niranjan Hembram all are of Neturia PS were performing mobile duty vide Neturia PS GD No-465 Dt. 11.03.23 & CC No- 801//23 Dt. 11.03.23 at PS area and on 11.03.2023 at about 17:15 hrs received a credible source information that one Hyva Dumper loaded with illegal sand coming from Madhukunda side towards Sarbari side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately moved towards Murgaboni More and at about 17:35 hrs reached at Murgaboni More found that above noted Dumper was coming from Madhukunda side and suddenly the driver stopped the vehicle there after seeing the police party then he got down from the vehicle and started running towards the village area. We chased to apprehend the driver and managed to apprehend him. On being asked to produce documents/challan in respect loaded sand in the vehicle as well as the papers of the vehicle, but failed to produce. On being asked he disclosed his identity as noted above. On preliminary enquiry and as per his statement it could be learnt that he along with owner of the vehicle JH 10AZ 3914 procured the illegal sand from Madhukunda side illegally.

So, there is reason to believe that the driver and registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sarbari side knowing it to be stolen.

Accordingly, I seized the vehicle loaded with sand approx 700 C.FT. at 17.55 hrs under proper seizure list duly signed by witnesses. So, the driver and registered owner of the vehicle have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of vehicle No- JH 10 AZ 3914 U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
