Sub: FIR regarding Fire Incidence at Salchura Intake Pump House Causing damage of HT/LT/Control Cable of All Six (06) Nos. Skid Pump.

Dear Sir,

I am directed to intimate you as under

In reference to the subject matter above, this is to inform you that on 27.02.2023 at about 2:30PM suddenly fire broken out in grass at Saltura Intake Pump House and spread very rapidly in the nearby cable gallery area. Immediately all the running pumps were switched off to prevent any further accident and damages to the equipment. After extinguishing the fire, it was found that major portion of HT/LT/Control Cable of all the Six (06) Pump got damaged badly at one location. On primary investigation, it seems that this fire was put by some unknown miscreants of nearby area. Similar type of incidence also happened in the previous night i.e. on 26.02.2023. The total damaged of property due to fire is approximately of Rs. Eight Lakhs. These pumps are used to supply water to 2X600 MW RTPS plant, Raghunathpur. Due to non-availability of these vital pumps, water scarcity in the plant would take place due to which, power generation may be hampered or completely outage of generation. The above loss is the loss of National Property. [(Details of the complaint may be seen from the enclosed document of SE(E), PWS & Colony Maint. Dtd.28.02.23 and Dy.CE(Electrical)]. Some of the photographs of the place of incidence are also enclosed.

In view of the above I am further directed to request you to kindly arrange to lodge FIR to the above effect for your necessary action in the matter.
