Respected Sir,

In producing herewith one arrested accd. person namely Datya Nath Bouri (30 Yrs) S/o Mihir Bouri of Vill- Churmi, PS- Para, Dist- Purulia with seized article i.e 20 (Twenty) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list. I beg to submit that today (14.03.2023) at 11.35 hrs. during my NAKA checking duty, I found that one person namely Datya Nath Bouri (30 Yrs) S/o Mihir Bouri of Vill- Churmi, PS- Para, Dist- Purulia coming from Charpatia side through Nadiha-Charpatia pitch road and reached at near Old Post Office, Nadiha. I search him and found that the above noted person was carrying Country Spirit contained in bottles named as "DIL KHUSH". I asked the above noted person to produce valid papers in respect of the Country Spirit, but he did not have any authorization or license in support of said Country Spirit. So I seized 20 (Twenty) bottles of "DIL KHUSH" Country Spirit containing 600 ml each which were kept in his gunny bags. I prepared seizure list and label in presence of witnesses duly signed by them. I also arrested the above noted person maintaining all rules and guideline as laid down by NHRC/WBHRC and informed his family members. The whole process has been completed in between 11.35 hrs. to 12.05 hrs. I also interrogated him thoroughly and during interrogation he confessed his guilt and also stated that he has stored huge quantity of Country Spirit in his house for selling.

The above noted arrested accd. namely Datya Nath Bouri (30 Yrs) S/o Mihir Bouri of Vill- Churmi, PS- Para, Dist- Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Datya Nath Bouri (30 Yrs) S/o Mihir Bouri of Vill- Churmi, PS- Para, Dist- Purulia and arrange for its investigation.
