Sir,

I had the grimmest shock of my life the other day. When We have came back from Kolkata to Dubra in my own residence on 14.03.2023 at around 7.00 am for Your kind information that I, and my wife went to Kolkata for my personal work on 04.03.2023 at 8.30 pm onwards and back 14.03.2023 in this period the thief stealing some good gold ornament and cash rupees in the time being.

No one says on my house. There are two rooms on the ground floor and a Separate Kitchen, in which We keep some Gold ornament, Money and other things which are rarely required for use occasionally such as Chain 01 no., ear ring 02 set., Neckless (one small and one big), Nose ring-01 no. and Nose ring with diamond- 01 no., Ring-01 no., 03 set Silver footing and 02 set wrist watch- 01 is gents and other is ladies.

The thieves broke open the lock of two rooms, three almirah and a divand and stealed all above mentioned ornaments (made in gold) and Rs.17,000 to Rs.25,000.00 cash.

Please treat this note as an official complaint, and record it in the F.I.R

You are requested to interrogate the local suspects and take necessary legal action in this regard.
