

Since we had recently started our Store setup, so for the watch and ward of our materials we had deputed 02 Nos. of Local Night watchmen named Mr. Hapan Kalbarta and Mr. Sadhan Kalbartta both from VIII+PO- Dubra, PS- Para, Dist- Purullia,

So, in reference with the aforesaid context, this is to request you to kindly Lodge the FIR against unknown miscreants for the theft of approx. 01 MT of our steel/iron materials lies inside our store premises.
