Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd, person namely Mihir Sing Sardar (30yrs) S/o-Lt. Ram Sing Sardar of Vill-Karmatand PS-Puncha, District- Purulla with seizure of 03 (three) white plastic jarican containing total approx 25 lit ID liquor, which was seized under proper seizure list I beg to submit that today (06/03/2023) at 17:45 hrs while myself along with 1) C/1117 Sadananda Mahato and 2) C/349 Manik Pradhan both of Puncha PS were performing anticrime mobile duty near Karmatand village. During mobile duty received source information that one Mihir Sing Sardar (30yrs) S/o-Lt. Ram Sing Sardar of Vill-Karmatand PS-Puncha, District- Purulla has illegally stocked liquor in his house at Karmatand village under PS- Puncha & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to said place to work out the information. At 18:05 hrs after reaching Karmatand village held raid in the house of Mihir Sing Sardar (30yrs) S/o-Lt. Ram Sing Sardar of Vill-Karmatand PS-Puncha, District- Purulla and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Mihir Sing Sardar failed to produce any valid documents in respect of selling of ID liquor as well as nobody, turned up to produce any valid documents. As such he committed offence u/s 46 A(c) BE Act and he was arrested and also seized 03(three) white plastic jarican containing approx 25 ltr ID liquor under proper seizure list duly signed by witnesses and labeled at the same and 01(one) ltr in a bottle is taken as sample which is sealed and labeled. During arrest the ground of arrest was duly notified, Issued arrest memo and handed a copy of the same to arrestee. I also issued check list us-11 (3), Cr.P.C




