Sub: Complaint for starting a specific case.

In producing herewith one arresated accd namely Haradhan Hansda (32) S/O Gurupada Hansda of vill- Rashikdih, PS\_Puncha, Dist- Purulia driver of Tractor bearing Reg No- WB55A-0371 along with one trolley without registration number, loaded with sand approx 75 cft along with seized said tractor along with trolley under proper seizure list. I beg to submit that today (29/03/2023) I, ASI Susanta Mishra along with 939 / Laltu Pal & C/817 Biswajit Kundu all of Puncha PS were performing anticrime day mobile duty at PS area vide Puncha PS CC No - 903 /23 Dt-28/03/23 and at about 05:45 hrs, I received credible source information that one Tractor is coming from Kalupara sand Ghat side towards Polmi side under Puncha PS loaded with sand illegally. Accordingly I intimated the matter to you over phone and as per your direction we rushed to the spot to work out the information. When we reached Kalupara sand ghat near Kalupara village at about 06:00 hrs we found that above noted Tractor was coming from Kalupara sand ghat side towards Polmi side but on seeing the police party the driver of above noted vehicle (Tractor) suddenly stopped approx 30/50 meter away from us, got down from the vehicle and started running. We chased to apprehend him and finally able to apprehend him. Then we searched the vehicle(tractor) and found that the vehicle (Tractar) having registration No- WB55A-0371, along with trolley without registration number loaded with sand 75 cft(approx). On interrogation the driver of the said tractor disclosed his identity as Haradhan Hansda (32) S/O Gurupada Hansda of vill- Rashikdih, PS\_Puncha, Dist- Purulia. On demand he failed to produce any valid documents in respect of above noted Tractor along with trolley loaded with sand approx 75 cft(aaprox). As well as D/L of the accd driver.

So, there is reason to believe that the driver and registered owner of this vehicle (tractor) and other have collected the said sand from Kalupara sand ghat of Kangsabati river either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose off the same at anywhere in a clandestine manner knowing it to be stolen as per their regular practice. Accordingly I seized the said Tractor bearing Registration No WB55A-0371 along with trolley without registration number loaded with sand approx 75 cft under proper seizure list duly signed him and other witness and arrested him in c/w this case . So the driver and registered owner of this vehicle (Tractor) of the said tractor and others have committed offence u/s-379/411/413/414/120B IPC & 21(1)(4) Mines and Minerals (Development and Regulations) act, 1957.

Under the above fact and circumstances a specific case may kindly be started against the driver and the registered owner of the vehicle (Tractor) bearing Reg. No.- WB55A-0371 along trolley with registration & others, under proper section of law and arrange for its investigation.
