Sub: Complaint for starting a specific case.

In producing herewith two arrested accd namely (i) Sukdev Mahato (25) S/O-Lt.Bhaskar Mahato of Vill- Nadiha,PS-Puncha,Dist-Purulia driver of offending seized Tractor bearing Reg No- WB55B-5779 along with one trolley without registration number, loaded with sand approx 100 cft and one co-accused namely Achinta Kr. Gorai (24) S/O- Dinabandhu Gorai of vill- Puncha, PS_Puncha, Dist- Purulia along with seized said tractor along with trolley under proper seizure list. I beg to submit that today (29/03/2023) I, ASI Anup Roy along with C/827 Rupchand Bauri & NVF/159 Dhiren Hansda all of Puncha PS were performing anticrime day mobile duty at PS area vide Puncha PS CC No - 903 /23 Dt- 29/03/23 and at about 15:45 hrs, I received credible source information that one Tractor is coming from Patharkata sand Ghat side towards Budhpur side under Puncha PS loaded with sand illegally. Accordingly I intimated the matter to you over phone and as per your direction we rushed to the spot to work out the information. When we reached Patharkata sand ghat near Patharkata village at about 16:05 hrs we found that above noted Tractor was coming from Patharkata sand ghat side towards Budhpur side but on seeing the police party the driver of above noted vehicle (Tractor) suddenly stopped approx 30/50 meter away from us, And Driver Sukdev Mahato and co- accused got down from the vehicle and started running. We chased to apprehend them and finally able to apprehend them. Then we searched the vehicle(tractor) and found that the vehicle (Tractor) having registration No- WB55B-5779, along with trolley without registration number loaded with sand 100 cft(approx). On interrogation the driver and co-accused of the said tractor disclosed their identity as (i) Sukdev Mahato (25) S/O-Lt.Bhaskar Mahato of Vill- Nadiha,PS-Puncha,Dist-Purulia (ii) Achinta Kr. Gorai (24) S/O- Dinabandhu Gorai of vill- Puncha, PS_Puncha, Dist- Purulia. On demand they failed to produce any valid documents in respect of above noted Tractor along with trolley loaded with sand approx 100 cft(approx) as well as D/L of the accd driver.

So, there is reason to believe that the driver and co-accused and registered owner of this vehicle (tractor) have collected the said sand from Patharkata sand ghat of Kangsabati river either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same at anywhere in a clandestine manner knowing it to be stolen as per their regular practice.

Accordingly I seized the said Tractor bearing Registration No WB55B-5779 along with trolley without registration number loaded with sand approx 100 cft under proper seizure list duly signed by them and other witness and arrested them in c/w this case. So the driver and co-accused and registered owner of this vehicle (Tractor) of the said tractor have committed offence u/s-379/411/413/414/120B IPC & 21(1)(4) Mines and Minerals (Development and Regulations) act, 1957.

Under the above fact and circumstances a specific case may kindly be started against the driver and co-accused and the registered owner of the vehicle (Tractor) bearing Reg. No.- WB55B-5779 along trolley with registration, under proper section of law and arrange for its investigation.
