Sub:- Prayer for starting a specific case against namely (i) Manik Mahato (43 yrs) s/o Lt. Bejo Mahato of Vill- Bandhgarh & (ii) Kailash Chowdhury (50 yrs) @ Pasial s/o Lt. Jagadish Chowdhury of Vill- Khalnadih (Chharrah) both are PS-Purulia (M), Dist-Purulia.

Respected Sir,

In producing herewith one accused person namely (i) Manik Mahato (43 yrs) s/o Lt. Bejo Mahato of Vill- Bandhgarh & (ii) Kailash Chowdhury (50 yrs) @ Pasial s/o Lt. Jagadish Chowdhury of Vill- Khalnadih (Chharrah) both are PS-Purulia (M), Dist-Purulia under arrest and the following seized article under seizure list enclosed herewith:

1) Twenty one (21) sealed plastic bottles (CS) containing 600ml each and labelled with DILKHUSH.

I ASI Ajoy Mukhapadhyay of this PS do hereby lodge this complaint regarding that today (03.03.2023) at about 16:35 hrs during my Spl. raid duty at Bandhgarh village received source information over telephone that the above noted accused persons have been selling CS liquor illegally and clandestinely in a Hut at Bandhgarh village under Purulia (M) PS. On receiving the reliable source information I communicated with you over telephone and as per your instruction I along with C/851 Amrit Banerjee & C/1137 Sridam Bouri both of Purulia (M) PS rushed to the spot to work out the information. On arriving to the spot at 17:05 hrs I apprehended the above noted persons after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended persons had disclosed their name & address as noted above. I asked them to produce any valid paper in support of selling that liquor but They failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party and accused persons in the seizure list and the label in between 17:15 hrs to 17:25 hrs. One bottle 600 mlliquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness & accused persons on seizure list and label. After this I arrested that accused persons namely (i) Manik Mahato (43 yrs) s/o Lt. Bejo Mahato of Vill- Bandhgarh & (ii) Kailash Chowdhury (50 yrs) @ Pasial s/o Lt. Jagadish Chowdhury of Vill- Khalnadih (Chharrah) both are PS-Purulia (M), Dist-Purulia after preparing proper memo of arrest.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against noted above accused persons under proper section of law and arrange for investigation.
