The fact brief is that today (06.03.2023) at 09:05 hrs while I along with force 1) C/178 Tulsi Mahato & 2) C/994 Srikanta Kumbhakar both of Purulia (M) PS left the PS for day mobile duty vide Purulia (M) PS CC No 726/23 and GDE No 261 Dt. 06.03.2023 in PS area. During my day mobile duty, I received a tip off at 13:45 hrs that a suspicious tractor was loading sand near Katabera Ghat of Kansai River. Accordingly I contact with I/C Purulia (M) PS and as per his direction, I along with force proceeded towards Katabera Ghat to work out the tip off. While I along with force arrived at Katabera Ghat and found that 01 (one) tractor was loaded sand at Katabera Ghat of Kansai river. I along with force intercepted the vehicle (Tractor) having bearing Engine No-RUL2EAN0849, Chassis No. MBNABAEXPJRL04292 attached with Trolley loaded with Sand approx 100 Cft. and I found the vehicle as well as goods as identical as I received prior information. I moved through the surrounding area to trace out said un known miscreants but nobody was found to stand it ownership. The owner of the said vehicle as well as driver may be loaded said sand by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that they in cahoots with the owner of the vehicle procured the said sand form Kansai River near Katabera Ghat under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (tractor) Bearing Engine No-RUL2EAN0849, Chassis No. MBNABAEXPJRL04292 attached with Trolley loaded with Sand 100 Cft. (approx) under proper seizure list at about 15.45.hrs to 16.15 hrs in presence of available witnesses duly signed by him. Thereafter, I brought the said seized tractor to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against the owner and the driver of the vehicle as they committed offence u/s 379/411/120B of the IPC & 21(I)(4) of Mines and Minerals (R&D) Act-1957.
