Sub:- Prayer for starting a specific case against namely Dukhu Rajwar (55 Yrs) s/o Late Haripada Rajwar of Vill- Namo Surulia, PS-Purulia (M), Dist-Purulia.

Respected Sir,

In producing herewith one accused person namely Dukhu Rajwar (55 Yrs) s/o Haripada Rajwar of Vill- Namo Surulia, PS-Purulia (M), Dist-Purulia under arrest and the following seized article under seizure list enclosed herewith:

1) Eighteen (18) sealed plastic bottles (CS) containing 600 ml each and labelled with DILKHUSH.

I ASI Ajoy Mukhopadhyay of this PS do hereby lodge this complaint regarding that today (06.03.2023) at about 18:25 hrs during my day Mobile duty in PS area received source information over telephone that the above noted accused person has been selling CS liquor illegally and clandestinely from near Shib Mandir at Namo Surulia village under Purulia (M) PS. On receiving the reliable source information I communicated with you over telephone and as per your instruction I along with C/248 Arabinda Roy & C/241 Sumit Chakraborty of Purulia (M) PS rushed to the spot to work out the information. On arriving to the spot at 18:55 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party and accused person in the seizure list and the label in between 19:05 hrs to 19:15 hrs. One bottle 600 mlliquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness & accused person on seizure list and label. After this I arrested that accused person namely Dukhu Rajwar (55 Yrs) s/o Late Haripada Rajwar of Vill- Namo Surulia, PS-Purulia (M), Dist-Purulia after preparing proper memo of arrest at 19:20 hrs.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against noted above accused person under proper section of law and arrange for investigation.
