As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized, and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 01.10 P.M.. after completion of inspection & necessary formalities.
